Students could be presented with a speech and be asked to compare reading the speech to watching a video of the speech.

Students will evaluate a speaker's argument and distinguish between solid, supportive evidence and weaker details that do not directly link to the topic. One way to approach this is to analyze several speeches or debates.

Student may use a graphic organizer as a note-taking tool to categorize and classify which claims in the speech are supported by clear evidence and which reasons are not.
