- 3. Rubenia Franco is prohibited from reapplication for an educator certificate in the State of South Dakota until completion of an educator preparation program or for one-year.
- 4. The Order and Findings of Fact and Conclusions of Law are a public record pursuant to SDCL § 13-42-17.1 and ARSD 24:18:04:05.
- 5. Notification of this denial is to be placed on the NASDTEC registry and be placed in applicant's permanent certification file within the South Dakota Department of Education.

This constitutes final agency action and may be appealed to circuit court pursuant to ARSD 24:18:02:06.

Rubenia Franco filed an application for an International Exchange Permit which was activated on June 16, 2023. After a review of the entire file, the Secretary enters the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- 1. On or about November 28, 2023, the South Dakota Department of Education Office of Educator Certification (hereinafter "Department") served a Notice of Intent to Deny Educator Certificate on Rubenia Franco (hereinafter "Franco") via first-class mail and email. Franco responded to the email on January 3, 2024, confirming she received the Notice. See Exhibit A attached hereto and made a part of this document.
- 2. The Notice of Intent informed Franco that if she failed to request a hearing within 30 days after service of the notice, the allegations of the Notice would be accepted as true by the Secretary.
- 3. The Department received no request for hearing from Franco within the 30-day period.
- 4. Franco lacks the educational requirements for an International Exchange Permit pursuant to ARSD 24:28:09:20, as she does not have a bachelor's degree.
- 5. Additionally, Franco failed to upload documentation to indicate she has a valid J1 or H1B visa as required by ARSD 24:28:09:20.

CONCLUSIONS OF LAW

- 6. Grounds for the denial or non-renewal of an educator certificate are provided in SDCL § 13-42.
- 7. The Secretary of the Department of Education has the power and authority to refuse to issue or

renew a certificate. SDCL § 13-42-9.

- 8. Franco's failure to have the educational and visa requirements necessary for certification deem her incompetent and support the Department's intent to deny in violation of SDCL § 13-42-9.
- 9. Any Conclusion of Law more properly designated as a Finding of Fact is hereby so designated.
- 10. Franco's application should be denied pursuant to SDCL § 13-42-9.
- 11. Franco should be prohibited from reapplication for an educator certificate in the State of South Dakota until completion of an educator preparation program or for one-year.
