South Dakota defined "comparable to same-age peers" as any child who received a standard score of -1.50 or above the norm on the Battelle Developmental Inventory II (BDI-2) scoring chart.

South Dakota utilizes the BDI-2 to gather data for this indicator. When a child enters and exits the Part C program, the child is assessed in the areas of cognitive, physical, communication, social-emotional, and adaptive development using the BDI-2. The baseline entry scores are compared to the exit scores in the five evaluated areas of development to determine progress in the three indicator outcome areas.
