About WIDA EL Assessments

What is WIDA?

WIDA stands for World-Class Instructional Design and Assessment. The WIDA consortium is a group of states dedicated to the design and implementation of high standards and equitable educational opportunities for English learners. South Dakota is one out of 39 states that belongs to the WIDA Consortium. The **WIDA** Consortium provides South Dakota with English language proficiency assessments for student in grades K-12, professional development opportunities, and English language proficiency standards.



ACCESS for ELLs 2.0 is a secure, large-scale English language proficiency assessment administered to KG through 12th grade students who have been identified as English learners. The assessment is given annually to monitor students' progress in acquiring academic English language

proficiency. The ACCESS for ELLs 2.0 assessments are aligned to the WIDA English Language Development Standards and assess students' proficiency in four domains: listening, speaking, reading, and writing.

What are my responsibilities?

In the above section you will see that important dates and timelines are listed. It is important to remember that all ordering of test materials is completed through the SD DOE.

What is my responsibility?

You need to ensure that all EL students are properly identified as EL in Infinite Campus. This is very important because information is pulled from Infinite campus for ordering the necessary assessment materials. The file was pulled on **November 27, 2017**. Please note that any

<u>new</u> students that arrived after the pull date will be added later.

It is also important to

remember that students need to be identified in campus as EL as soon as the screener assessment is completed. LEAs have <u>30 days</u> at the beginning of the school year to identify, screen, and notify parents of potential EL students and <u>two weeks</u> during the school year to complete this process.


WIDA offers a variety of resources for families regarding the WIDA EL assessments. It is important to keep families informed regarding their student's education.
