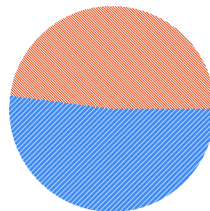

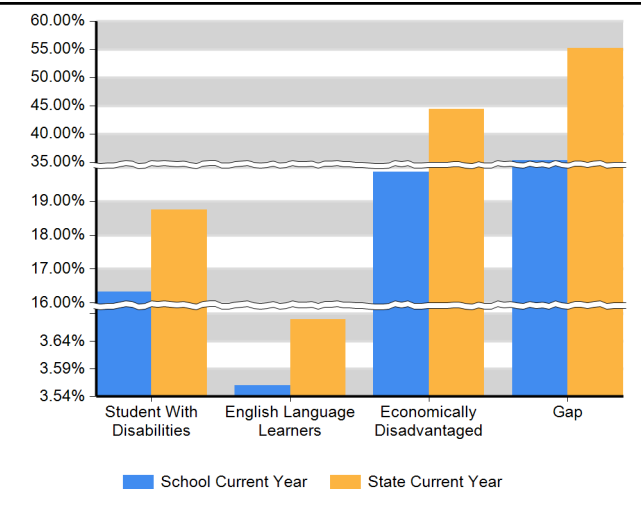

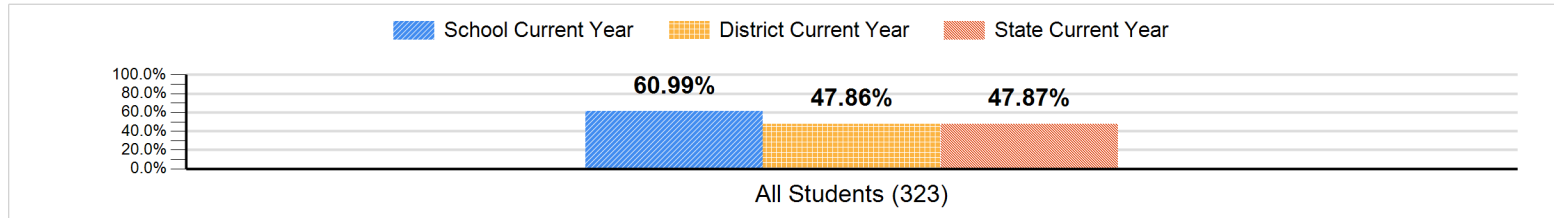
Student Population

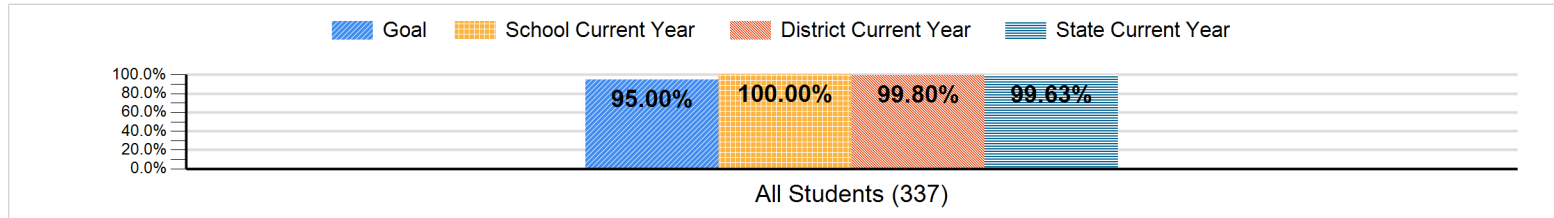

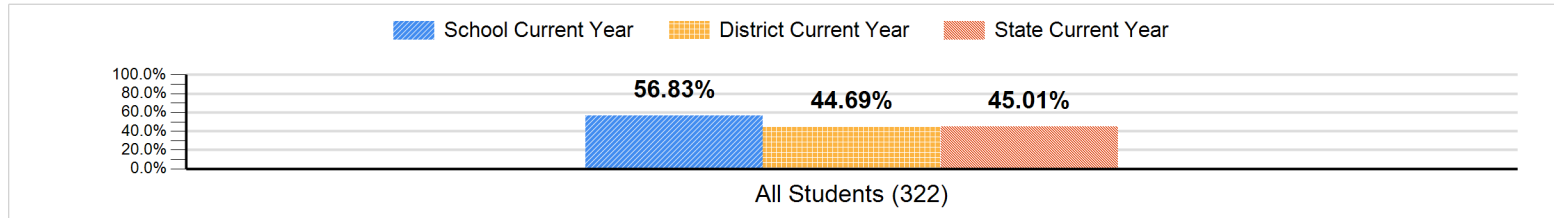

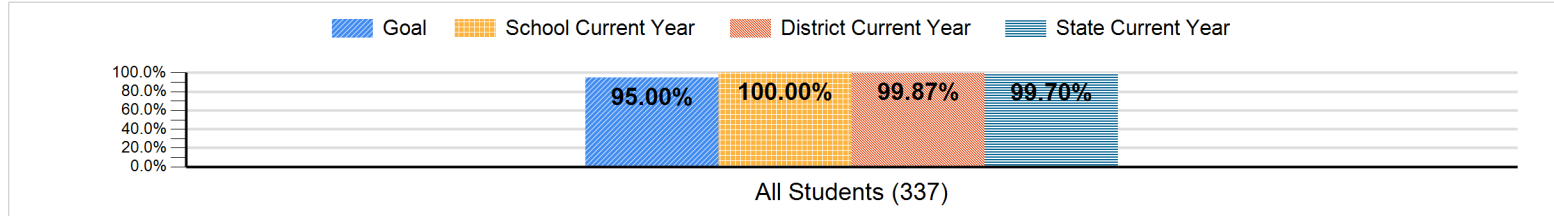

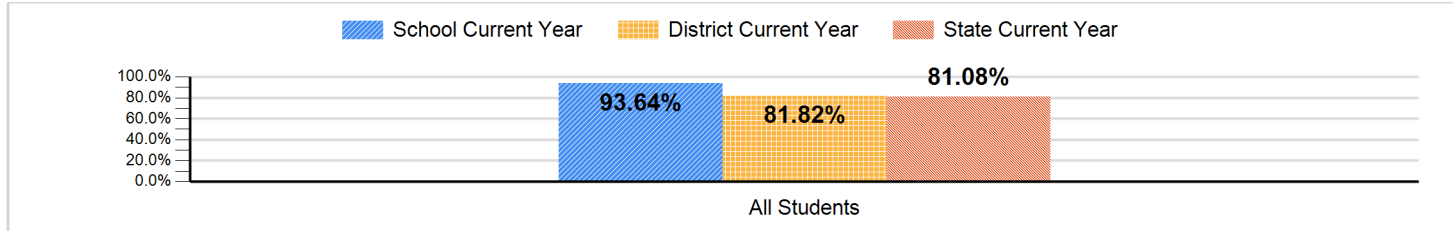
