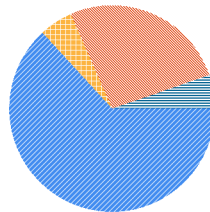

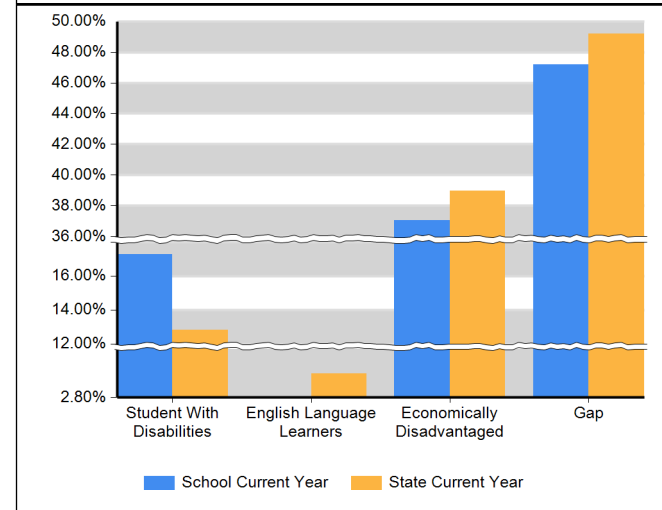

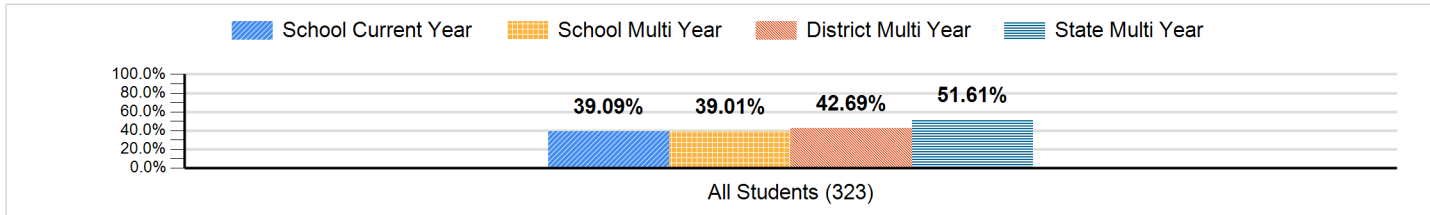
Student Population

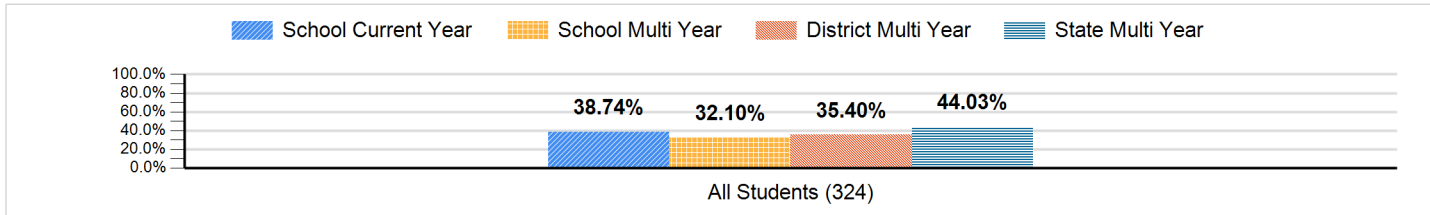

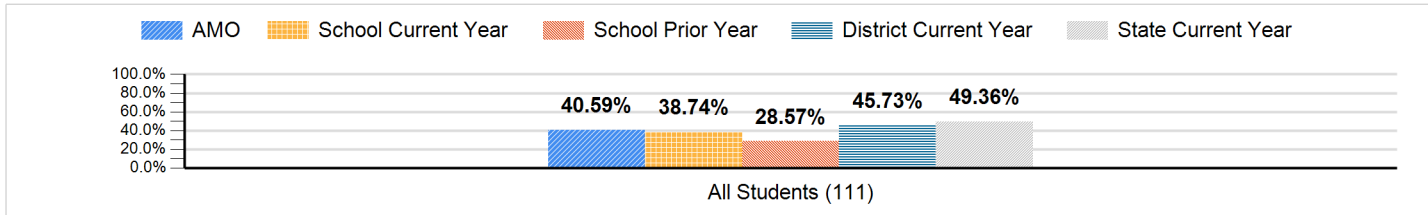

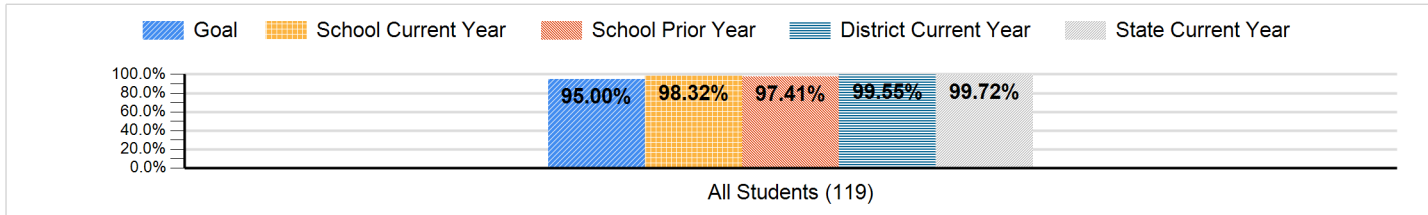

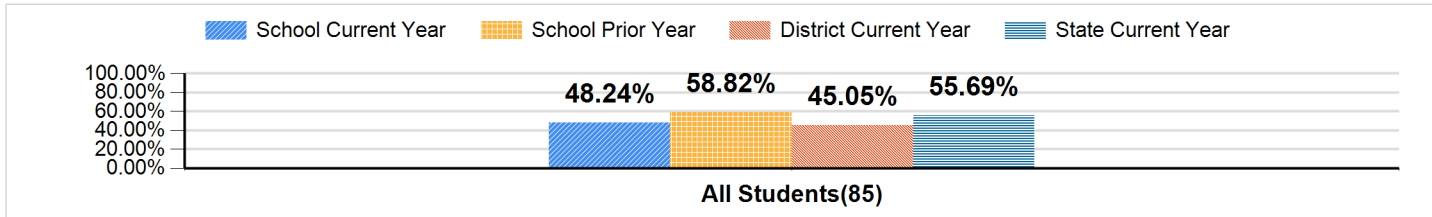
