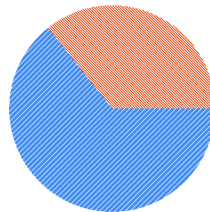

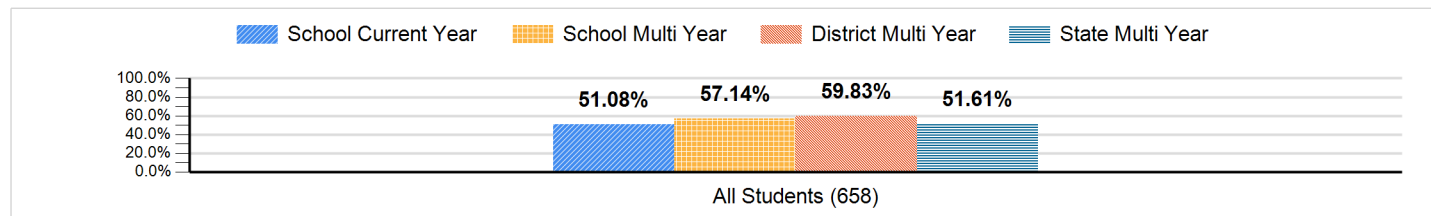
Student Population

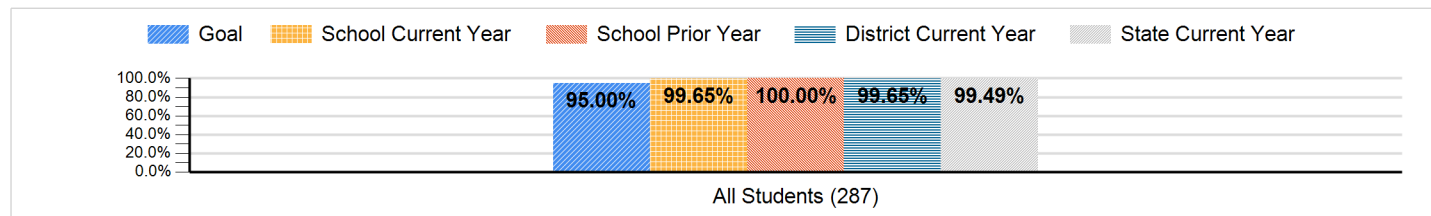

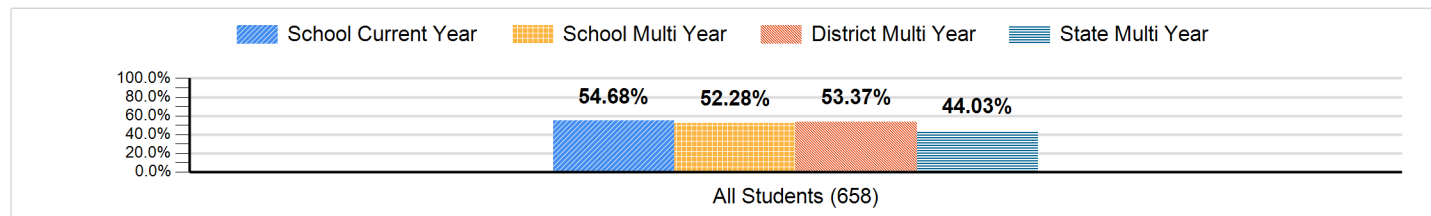

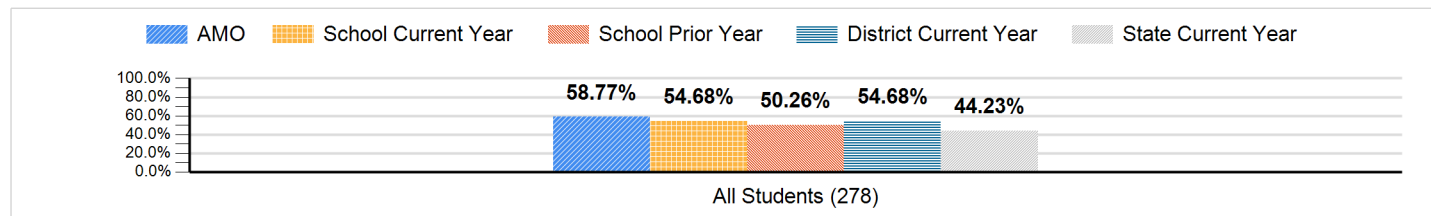

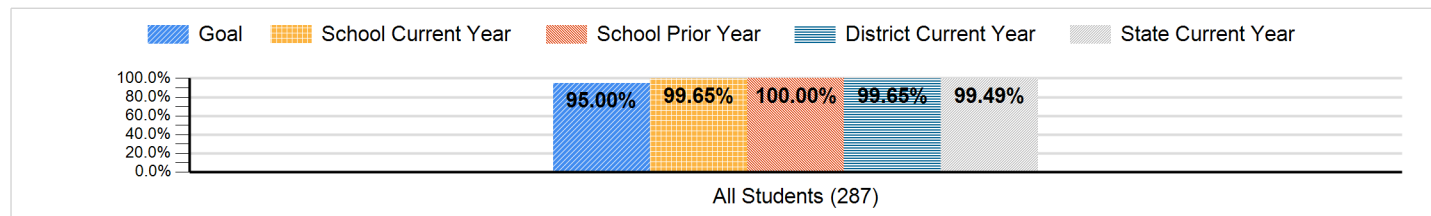

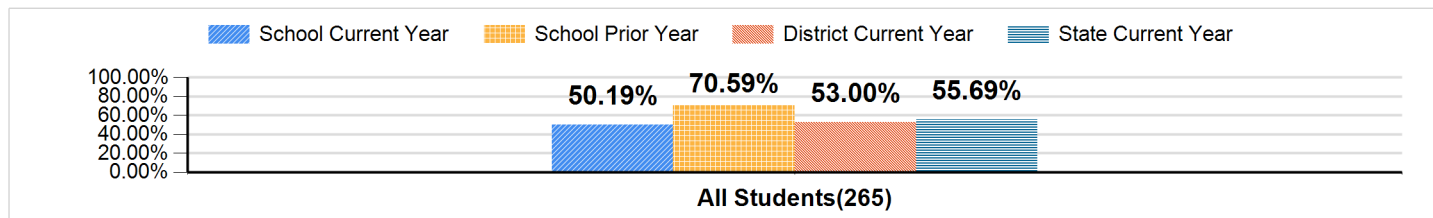

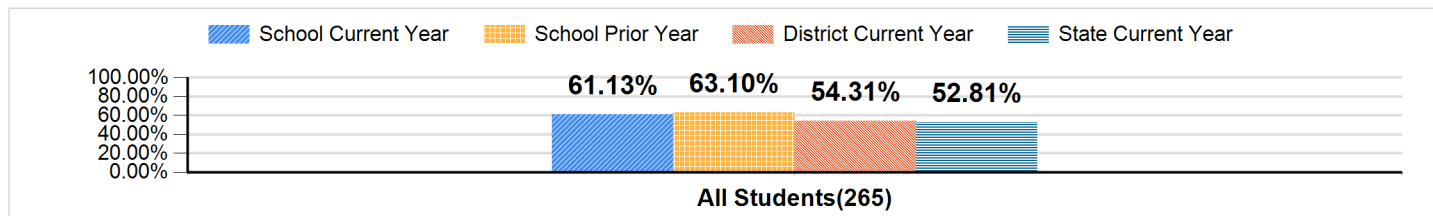
