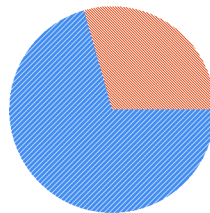

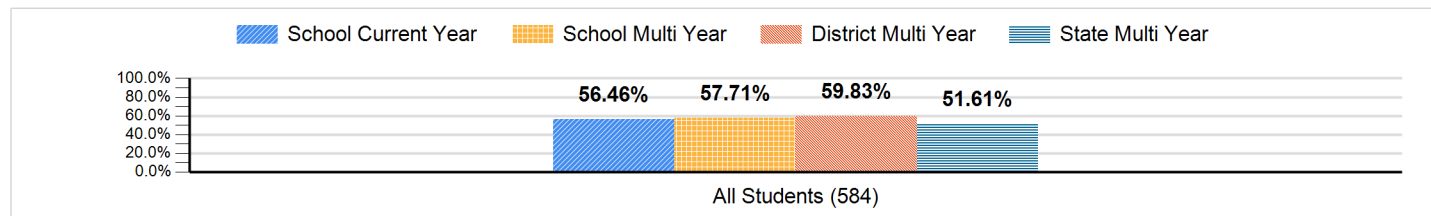
Student Population

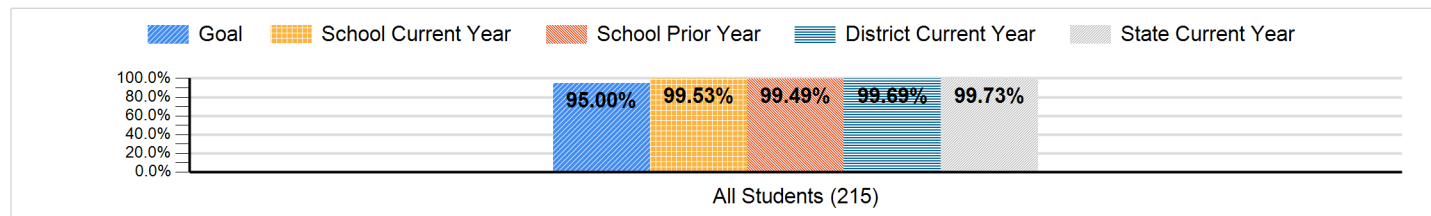

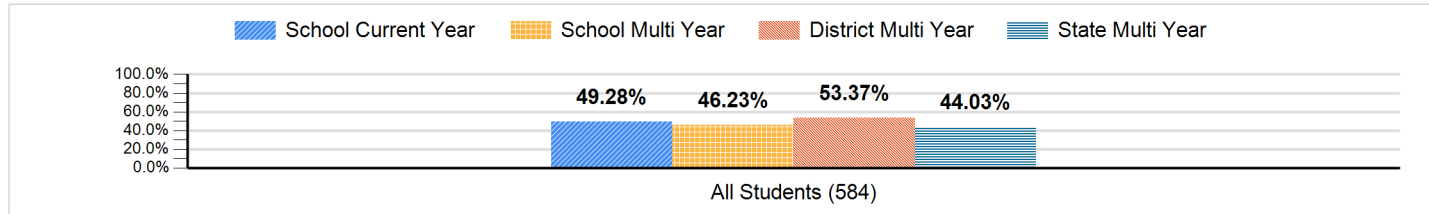

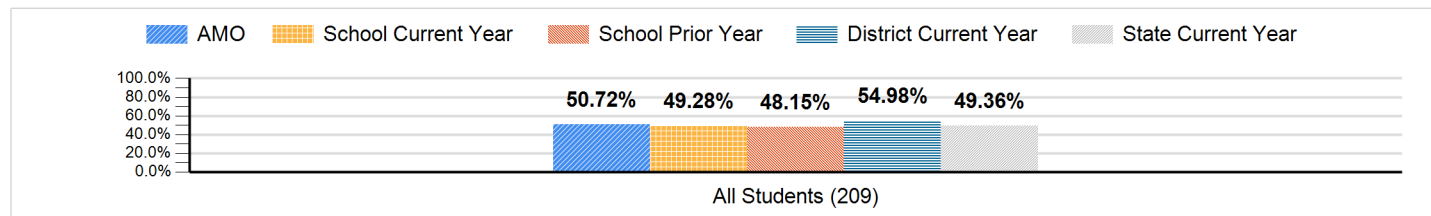

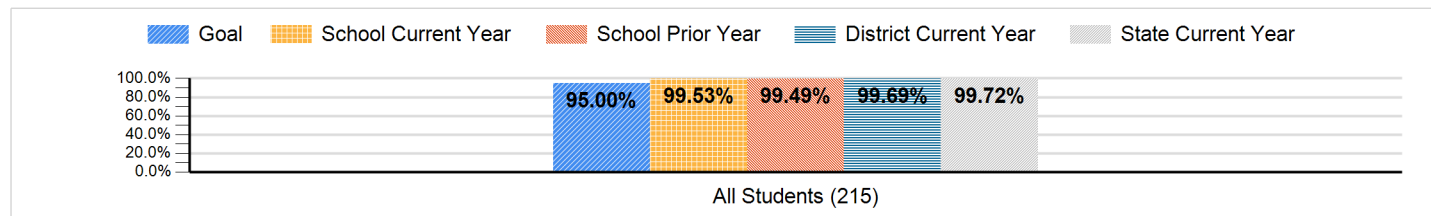

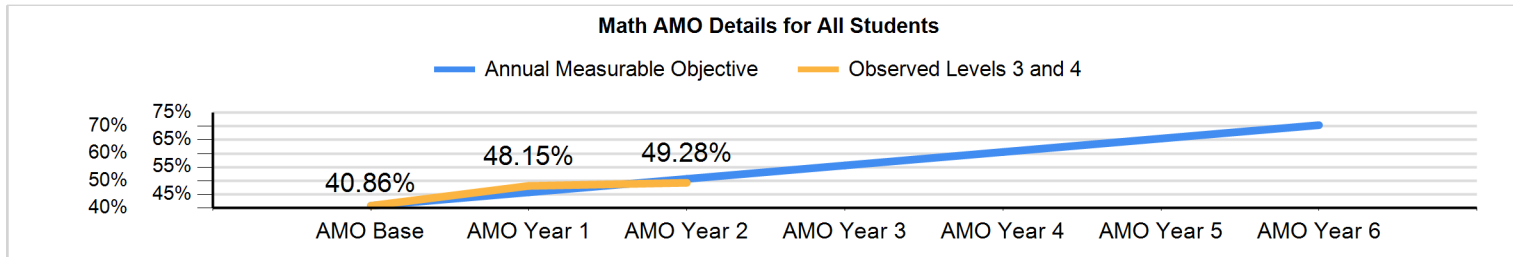

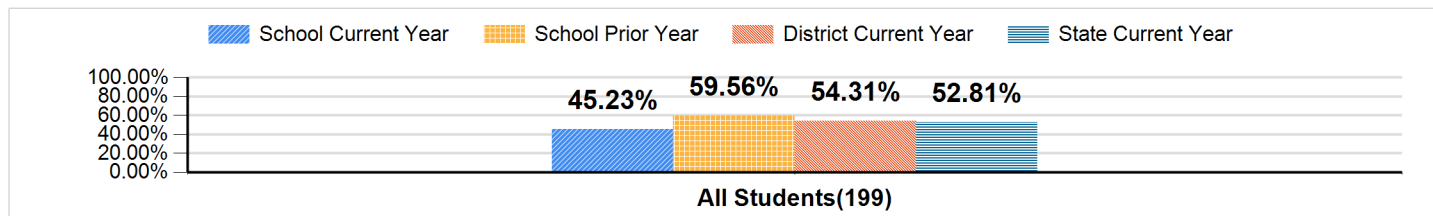

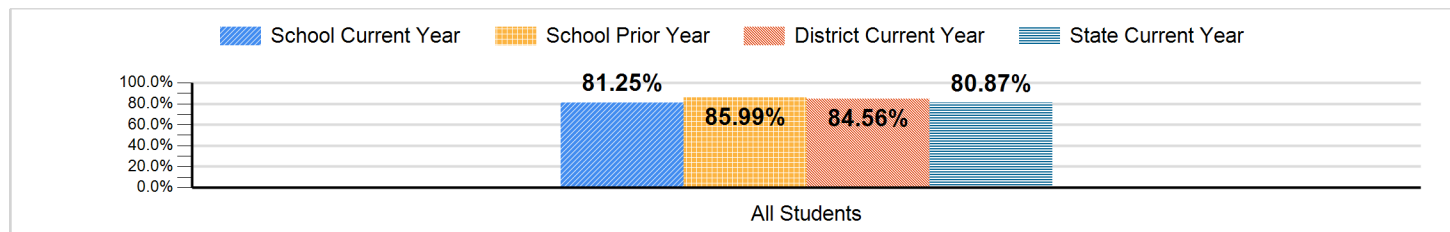
