Mr. Wieseler gave a report on thoughts on making tutor Fridays similar for both elementary and secondary. Holding students accountable for attendance and effort in elementary as well. Clark Colony title open house was November 22, December 12 was k-12 music concert. Mrs. Butterfield and students did a nice job on music concert. Camrose Colony program will be December 20, Hillside Colony program will be December 21. Two students will graduate at Hillside Colony on December 21. Semester test will be December 21 and 22 for grades 7-12. School will dismiss on December 22 at 1:30 p.m. Clark Colony program will be December 22. The teachers will attend a North Central Special Education in service in Warner on January 3. School will resume on January 4 and a regular day of school on January 5th. The GBB game will be in Doland with Great Plains Lutheran on January 8 at 6:30 p.m. January 12 is a full day of teacher in-service. The BBB game will be in Doland on February 16 at 4:00 p.m. with Clark/Willow Lake.

Mr. Hulscher gave a report on gave an update on the school/city library with plans to keep the two libraries separate for now. The current enrollment at Hillside High School is 15 students. Two students will graduate from Hillside High School during December. Mr. Hulscher gave a new updated schedule of vehicles. Mr. Hulscher spoke on the transportation report and the mileage of the district current car/suburban/buses. The 7-12 grade will be taking a trip to Watertown to watch the movie "Wonder". This is sponsored by the money from the ink cartridges and student council. There are two dates for a Nebraska field trip of February 25 or January 15. Tianna Tschetter has been elected Region FCCLA treasurer for the 2018-2019 school year. NSU Honor Band members were Jazzlyn Tschetter and Natasha Allerdings. The State FFA LDE has Danielle Houghtaling place 7th in public speaking and Tianna Tschetter place 4th in broadcasting. The following are the athletics: JH girls bb 0; HS girls bb 1; JH boys bb 1; HS boys bb 3; wrestling 0; and wrestling cheerleaders 2. A presentation on distracted driving will be for grades 7-12 on December 13. The DEA wrote a thank you for the breakfast. A copy of the senior privileges was given to the board member to review. A copy of the senior letter for the trip was given to the board members to review. The parents and student will sign the letter for the trip and return to the superintendent. The wellness committee needs to meet to review the district's wellness and nutrition policy.

The current and projected enrollment for the Doland School District. The Doland Center is at 102, Clark Colony is 14, Hillside Colony is 26, Hillside High School is 15, and Camrose Colony is 12. The total without pre-school is 169. The projected enrollment for the district in the fall of 2018 is at 156 students, and the fall of 2019 is at 156 students. These projected enrollments do not include preschool students or any Hillside High School students.

The Doland School District will hold the school board election on April 10, 2018. Julie Schneider and Jan Houghtaling are the board member positions which are up for election of a three-year term. The first day in which petition may be circulated is January 26, 2018.

The board of education held a discussion on the current buildings. Mr. Hulscher did contact Cooperative Architects.

The Doland School District was given a waiver by the Teacher Accountability Board. The Doland School must pay out \$12,513.00 to the certified teachers. The agreement between the staff and the Doland Board of Education must take place before February 1, 2018.
