

SOUTH DAKOTA BOARD OF EDUCATION STANDARDS  
NOTICE OF PUBLIC HEARING: CONTENT STANDARDS

A public hearing will be held at Sioux Falls New Technology High School, Presentation Room 189 2205 N Career Avenue, Sioux Falls, South Dakota on Monday, November 20, 2017, at 9:30 a.m. Central Time, to consider the adoption and implementation of content standards. This is the second of four public hearings regarding these standards.

The following standards will be considered during the hearing:

**Health Education:** The health education standards identify the core health concepts and the key processes and skills that are essential for adopting and maintaining health-enhancing behaviors.

**Oceti Sakowin Essential Understandings & Standards:** The Oceti Sakowin Essential Understandings & standards identify core concepts that are essential to understanding and teaching of the Oceti Sakowin history and culture.

**Business Management & Administration:** The business management & administration standards support students in developing technical skills in planning, organizing, directing and evaluating business functions essential to efficient and productive business operations.

**Capstone Courses:** The capstone courses support students in exploring a career cluster in-depth, assessing workplace skills and abilities, and developing leadership and employability skills for careers in each of the sixteen career clusters.

**Government & Public Administration:** The government & public administration standards support students in developing technical skills in planning and performing government functions at the local, state, and federal levels, including governance, national security, foreign service, planning, revenue and taxation, and regulations.

**Hospitality & Tourism:** The hospitality & tourism standards support students in developing skills in the management, marketing and operations of restaurants and other food services, lodging, attractions, recreation events and travel related services.

**Marketing:** The marketing standards support students in developing skills in planning, managing, and performing marketing activities to reach organizational objectives.

**Transportation, Distribution & Logistics:** The transportation standards support students in developing skills in planning the movement of materials and goods and related professional support services such as logistics and equipment maintenance and repair.

**English Language Arts:** The English language arts standards develop knowledge and skills students need to be college and career ready in literacy.

**Math:** The math standards develop mathematical fluency and understanding as well as problem solving and reasoning skills.
