Summer 2018 Wrap-Up Call – Debrief Meeting Minutes / NOTES

Celebrate Successes!

Thank you for all your hard work this summer to serve kids in South Dakota!

- Share success/wins/ new ideas that were a success from your own organization
 - Rapid City Meals on Wheels Partnerships allowed adults 60 + that are bringing children to the feeding sites to get a meal for free and the sponsor was reimbursed for those meals (Both Youth and Family Services and YMCA of Rapid City shared this as a success and would assist with other communities in the state how to establish prior the SFSP by contacting the local director and getting this arranged prior the feeding taking place.)

Meal on Wheels is not being incorporated into SFSP. The Rapid City sponsors were able to establish a partnership with their local director to reimburse an adult who was a guardian 60+ bringing children to their site. You would need to talk to your own Senior Meals coordinator/director to see if you could get that going in your community.

- Youth and Family Services also partnered with Black Hills Community Foundation for a grant to assist in feeding meals to adults at no cost to the adults, the funds from the grant covered their meals.
- Volunteer group, assisted with making sure all participants receive a smile and were encouraged to take their milk.
- Feeding SD Partnership for weekend backpacks of food, let the local backpack provider to your community know you are doing the SFSP and approximate number attending so they can coordinate a summer drop for you.
- Lessons learned, challenges encountered and how you overcame them...

- Local store closed which created additional adult meal participation, also found that due to food insecurity the children were very hungry and they could not be reimbursed for all the additional servings the school wanted to serve so they had to use additional funds of their own to cover those expenses; other things to keep in mind were assisting those without transportation to neighboring areas to purchase food when their SNAP benefits were available. Many didn't have storage for frozen foods, so they don't buy often which is a hardship. Families really appreciated having the program.
- o Challenge is not over preparing or under preparing if have an increase in participation.
- Off-site preapprovals /Field trips getting the changes in when they have short notice – suggest getting in menu and date preapproved and then if changes happen in last couple days prior – email the site location and number attending then. They must be approved prior the field trip, but if rest is approved in advance a modification at the last minute can be approved.

- Procurement Plan must be updated ANNUALLY Don't miss this Announcement and update your plan with new thresholds. From the July CANS Nutrition Bulletin:

Good news! A recently released memo from the Office of Management and Budget (OMB) has increased the purchasing thresholds, effective immediately. The threshold for micro-purchases has been raised from \$3,500 to \$10,000. The threshold for small purchases (also known as informal procurement, 3 bids & a buy, or quotes) has also been raised from \$150,000 to \$250,000.

What does this mean for you? This means, effective immediately, program year 2018-2019 your Local Agency can follow these thresholds. Just don't forget the South Dakota small purchase limit for **supplies and services is \$25,000** – that has not changed. Be sure to update your Procurement Plan to reflect any changes.

SCHOOL ELIGIBILITY can be reviewed in November after your local school district completes the October claim for each site. Another month between November 2018 and March 2019 may be used if there is a significant change in the community and the school site becomes eligible.
