

**TITLE II, PART A - IMPROVING TEACHER QUALITY PROGRAM**  
**REVISED ALLOCATIONS FOR SCHOOL YEAR 2011-12**  
**Updated January 27, 2012**

The Title II Part A funding cuts will be **deferred** and the reductions will be applied to each LEA's SY 2012-13 allocation amount.

(2) Revised amount based on US Department of Education Allocation tables released October 6, 2011 due to the "Continuing Appropriation Act, 2012" imposing across-the-board reductions of 1.503 percent.

(3) Second revised amount based on US Department of Education Allocation tables released January 6, 2012 due to the "Consolidated Appropriations Act, 2012," decreasing the across-the-board reduction from 1.503 percent to 0.189 percent.
