### Changes for the 11-12 school year

#### Section 301: Privacy Protection

- Only requires the last four digits of the signing adult's Social Security Number
- Removes collection of SSN for verification
- Implementation memo February 15, 2011: SP 19-2011

#### Section 305: Cooperation with Program Research and Evaluation of Child Nutrition Programs

- State agencies, local educational agencies, schools, institutions, facilities, and contractors participating in the Child Nutrition Programs are required to cooperate with the Department of Agriculture officials and contractors conducting evaluations and research.
- Implementation memo issued March 8, 2011: SP 22-2011
- Final rule issued June 29, 2011

#### Section 203: Potable Water

- ❖ Make free potable water available to children for consumption in the place where meals are served during meal service
- ❖ Implementation Memo April 12, 2011: SP 28- 2011, revised July 12, 2011

#### Section 202: Fluid Milk

- ❖ Offer a variety of fluid milk consistent with the Dietary Guidelines
- ❖ Schools serve only fat-free (unflavored or flavored) and unflavored low-fat milk
- ❖ Implementation Memo April 14, 2011: SP 29 - 2011

#### Section 102: Foster Children

- Foster Children are categorically eligible for free meals.
- Foster children may also be counted as part of the family.
- Implementation memo January 31, 2011: SP17-2011, revised March 16, 2011
- Interim rule published April 25, 2011

#### Section 302: Food Safety

- ❖ Applies the food safety requirements throughout the school campus where program foods are stored, prepared and served
- ❖ Implementation guidance issued May 18, 2011: SP 37-2011

#### Section 205: Equity in School Lunch Pricing

- ❖ Complete PLE worksheet to determine increase, keep a copy on file
- ❖ Implementation memo issued June 13, 2011: SP 39-2011

#### Section 112: Outreach to Households on the Availability of the School Breakfast Program

- Establishes requirements for conducting outreach in the School Breakfast Program (SBP).
- Implementation memo issued June 15, 2011: SP 40 – 2011

#### Section 206: Revenue from Nonprogram Foods Sold in Schools

- ❖ If nonprogram food is purchased with the nonprofit school food service account, all revenue must accrue back to the account
  - Food sold outside of program meals
  - Purchased with funds from the school food service account
- ❖ Interim rule issued June 17, 2011
- ❖ Implementation memo issued June 13, 2011: SP 39-2011

#### Section 307: Indirect Cost

- ❖ Guidance/rules pertaining to indirect costs
- ❖ Study will assess extent of indirect costs
- ❖ Implementation memo issued July 7, 2011: SP 41 - 2011

#### Section 204: Local Wellness Policies include

- ❖ Goals for nutrition, physical activity and wellness
- ❖ Guidelines to promote health and reduce obesity
- ❖ Implementation Memo Issued July 8, 2011: SP 42 - 2011

- Proposed rule due one year after implementation
