## SD-ACT Updates (for public-school districts only)

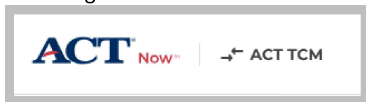
### SD-ACT Student Upload

Currently, all 10–12 grade students have been uploaded into ACT Now. This was a mistake, as only 11 grade students were supposed to be uploaded. ACT is aware of the issue and is working to correct it. Once the system reflects only juniors, an alert to notification will be sent to you.

### ACT Now To-Do List by Jan. 16, 2026

Assessment Coordinators need to:

- Log into ACT Now and [confirm participation](#).
- [Add event staff](#): Once this is completed, test event staff can complete modules in Test Center Manager (TCM). There is a toggle at the top of ACT Now to get to TCM.

### SD-ACT Training Provided by SD DOE Office of Assessment & Accountability

SD DOE will offer a training over SD-ACT on Jan. 28 from 10 a.m. -12:30 p.m. (CT) in Pierre. Topics covered include the material from ACT’s Jan. 13 training. There will also be time to ask questions and learn from other Assessment Coordinators. This will be a hybrid training – you can either attend in Pierre OR virtually.

## Accommodations for SD-ACT

Districts should be finishing up with requesting accommodations for the SD-ACT. District staff will need to create an account in Test Accessibility and Accommodations (TAA), which is in [ACT Success](#). If the Assessment Coordinator is not the Test Coordinator for the MSAA, please let us know via [email](#). If you have students that should be added to the MSAA system or deleted from the MSAA system, please send an [email](#) with student SSIDs and a sentence of which is needed and why (i.e. student transferred, change in decision by IEP team, etc.).

## SD-ELP (ACCESS Updates)

ACCESS testing materials should have arrived in district last week. As you prepare to begin testing, please take a moment to **double-check your student rosters in DRC**. If you notice any issues, reach out to Shari Lord as soon as possible so they can be resolved before testing begins.

Below are a few important updates:

- **Required Non-Disclosure Agreement:** For the SD-ELP (ACCESS) Assessment, all Assessment Coordinators and Test Administrators **must** sign the SD DOE Non-Disclosure agreement before proctoring the SD-ELP (ACCESS) assessment. Form can be found here: [SD DOE Non-Disclosure](#)
- Students identified as EL students after November 26, 2025, were not captured in the Pre-ID file upload and the district will need to follow the [New Student Upload Process](#).
  - Students are now visible in [WIDA AMS](#)
  - If you are administering WIDA ACCESS Online, make sure your students are entered in the appropriate registrations and accommodations are added if needed.

**Test Materials:** SD DOE orders all materials for the ACCESS and Alternate ACCESS assessments. If additional materials need to be ordered, you will need to place an [Additional Order](#).

- Make sure that you check for overage of materials before placing an additional order
  - Additional orders can be placed until 2.20.26

**Any educator who will be administering the ACCESS assessment must complete the appropriate training in the WIDA Secure portal**

## NAEP Updates

### NAEP Assessment Preparation Reminder

Schools should schedule Assessment Planning Meetings with their NAEP Field Assessment Coordinators if they haven't already. Enter demographic details, including SPED and EL information, for students selected to participate. For schools using their own devices, install and verify the NAEP application. At least 50% of devices must be verified before assessment day. The Verification Code is available on the school page in the AMS or by contacting [Betsy Chapman](#).
