SD-ACT Accommodations

Districts should begin requesting accommodations for the SD-ACT as soon as possible. District staff will need to create an account in Test Accessibility and Accommodations (TAA), which is in ACT Success. ASVAB testing update

Currently, the ASVAB Career Exploration Program does not have a traveling test administrator to come to schools to test students. As there is no way of knowing what future guidance will be, schools are encouraged to take advantage of the Internet-based ASVAB (iCAT) which can be administered by school staff. School staff can do a minimum training (approximately 30-40 minutes) and select dates and times during the school year to meet their testing needs.
