General Assessment Updates

TIDE Updates

New features that went live on Nov. 9:

- While viewing a student's detailed record, you now have access to **Print** options—such as printing **test tickets** or **test settings and tools**—directly from that page for the selected student.
- A student's ID now appears alongside their name in the header of the **Student Details** tabs, making it easier to confirm you're viewing the correct record at a glance.
- Previously, favorite searches could only be saved in the **Advanced Search** section of *Plan & Manage Testing*. Now, this feature is also available in the **Basic Search** section and in **Student Search**.
- You can now save frequently used tasks in TIDE and access them anytime from the new My Favorite Tasks tab, conveniently located in the top banner of the system.
- Users will now be required to complete Multi-Factor Authentication (MFA) once every 30 days. This means they'll receive a verification code by email every 30 days, which must be entered to access the Cambium systems.

All District Assessment Coordinators (ACs) should have received a welcome email into the ACT Now Platform.

- Districts will NOT upload students into ACT Now. The State will do an initial upload of all juniors into ACT Now in early January.

MvAC1

Students are not required to have a MyACT account to participate in the SD statewide ACT test administration this spring. If they do <u>not</u> have a MyACT account set up (to link their test event to), they <u>will not</u> be able to utilize their free score sends to postsecondary institutions, and they <u>will not</u> have access to their score reports following testing. They also will not be able to include any interest inventory items, grades, courses taken, etc.


Test Materials. SD DOE orders all materials for the ACCESS and Alternate ACCESS assessments. It is important to verify that all newly identified EL students are properly identified in Infinite campus as EL students. SD DOE uses the data from Infinite Campus to generate the Pre-ID file.

- Each district needs to ensure that their EL students are properly identified in Infinite Campus as English learners. Please ensure that you have verified your English learner data by Fri., Nov. 21, 2025.
- Students identified as EL students after Nov. 26, 2025, will not be captured in the Pre-ID file upload and the district will need to follow the New Student
 Upload Process. More information about this is coming soon.

MSAA Update

Please ensure that students participating in the alternate assessments are accurately marked in Infinite Campus.

The data pull for MSAA is scheduled for Dec. 1. After this date, any students not included in the initial pull will need to be added manually to the MSAA system by the SD DOE.



Literacy Initiative Update (Share with your ELA teachers!)



The Department of Education is looking for educators interested in presenting at its upcoming literacy conference, to be held June 16-17, 2026. If you are skilled in areas such as the Science of Reading, tiered literacy instruction, assessment, or other literacy-related topics, submit a proposal.
