




Early brain development is time sensitive.

Delays may compound without timely support.

Family engagement is strongest early on.

- Overall number of services delivered dropped due to change in collection period. (Q2 to Q3)
- One instance of noncompliance identified.
- Subsequent data analysis showed this was a one off and not a systemic issue.
- Collection period for FFY 2025 will return to Q2



Indicator 7: 45-Day Timeline Definitions

% of eligible infants/toddlers with IFSPs whose initial evaluation, assessment, and IFSP meeting, were conducted within Part C's federally defined 45-day Timeline.

Clock starts when referral is received after which there are 45 days to get the IFSP signed to remain compliant.

Indicator 7: 45-Day Timeline Importance


Early access could mean better developmental outcomes

Builds trust and engagement with families

Take advantage of the short amount of time we have to work with the child.

Indicator 7 Data

- Overall number of IFSPs signed dropped due to change in collection period. (Q2 to Q3)
- There were no instances of noncompliance identified. 100% compliance target reached.
- We believe the increase in exceptional family circumstances comes in part from new and more accurate data system.
- Potential weather events more common in Q3 than Q2, potentially driving EFC up.
- Collection period for FFY 2025 will return to Q2



Indicator 8: Early Childhood Transition Definitions

% of toddlers with disabilities exiting Part C at age three with timely transition planning for whom the Lead Agency has:

Continuity of services can potentially prevent developmental regression.

Determine if child is potentially eligible for Part B 619 (3-5 yr) services.


IDEA Part B 619 required to determine if a child transitioning from Part C is eligible for Part B services 90 days before child's 3rd birthday.

Begin to build relationship between LEA and family

Reduces family stress and continues to build trust.

Indicator 8 Data

- There were no instances of noncompliance identified. 100% compliance target reached.
- There was one exceptional family circumstance for Indicator 8(C) which was investigated and verified as a parent driven reason.
- FFY 2023 Indicator 8 data was also 100% in compliance.




