Only plain water, plain low fat milk, plain or flavored non-fat milk or 100% fruit or vegetable juice (may be diluted with water) with no added sweeteners are allowed for Middle School. The SFA must ensure that all food and beverage items meet the Smart Snack requirements, based on the level of the school (elementary, middle, high) where they are sold and nutrition standards. 2. The Food Safety Checklist in the Food Safety Plan is not completed as described. The checklist must be completed at least monthly, and the SOPs and checklist must identify an accurate reflection of frequency. 3. Reviewer observed pineapple from Indonesia, without supporting documentation to justify the purchase/offering. All foods served must be produced in the United States, or have documentation demonstrating that the domestic product is not available, or that there is a substantial cost differential between foreign and domestic product. 4. The Fresh Fruit and Vegetable Program's cost documentation does not support the school sclaim for reimbursement. Per serving cost calculation resulted in the SFA overclaiming by \$0.16. This will result in a fiscal calculation. To be in compliance, the school participating in the FFVP must ensure that it claims reimbursement only for allowable items for which it has maintained the proper documentation.
