<p>What makes a good group member?</p> <p>How does a listener know what to believe?</p>	<p>Good discussions depend on participants who have prepared ahead of time, ask thoughtful questions, and value the viewpoints of others, even when they disagree.</p> <p>Listeners should think critically about the information and arguments given by a speaker, rather than taking them at face value.</p> <p>Knowing a speaker's motive can help determine how trustworthy their argument is.</p>

**Relevance and Applications:** How might the skills in the standards be applied at home, on the job or in a real-world, relevant context?
