

Unpacked South Dakota State Mathematics Standards

Purpose: *In order for students to have the best chance of success, standards, assessment, curriculum resources, and instruction must be aligned in focus, coherence, and rigor. Unpacked standards documents are intended to help align instruction to the focus, coherence, and rigor of the South Dakota State Mathematics Standards. The standards have been organized in clusters as they are not so much built from topics, but rather woven out of progressions. Not all content in a given grade is emphasized equally in the mathematics standards. Some clusters require greater emphasis than others based on the depth of the ideas, the time that they take to master, and/or their importance to future mathematics or the demands of college and career readiness. To say that some things have greater emphasis is not to say that anything in the standards can safely be neglected in instruction. Neglecting standards will leave gaps in student skill and understanding and may leave students unprepared for the challenges of a later grade.*

Domain: Reasoning With Equations and Inequalities		Grade Level: Algebra I

<p>A1.REI.D.11 (i): Please be sure the students are aware that the process of finding the x-value by graphing the left and right expressions is true for more than linear, quadratic, and exponential models. (ex: rational, trigonometric, absolute value, cubic, quartic)</p>		
<p>A1.REI.D.12: A <i>strict inequality</i> uses greater than (>) or less than (<) symbols. An <i>inclusive inequality</i> uses greater than or equal to (\geq) or less than or equal to (\leq) symbols.</p>
