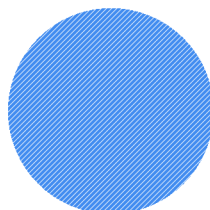

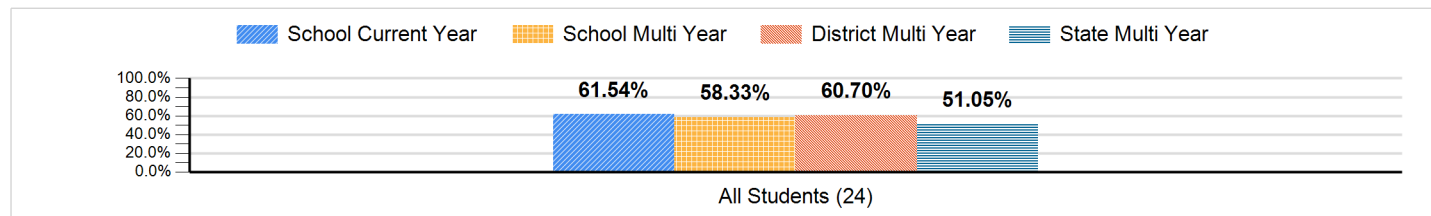
Student Population

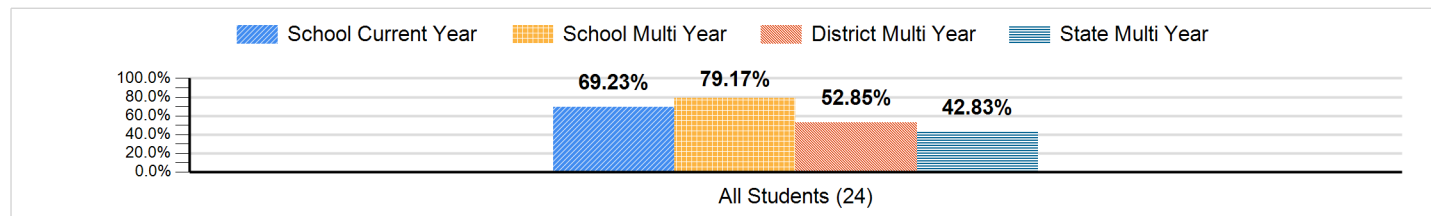
