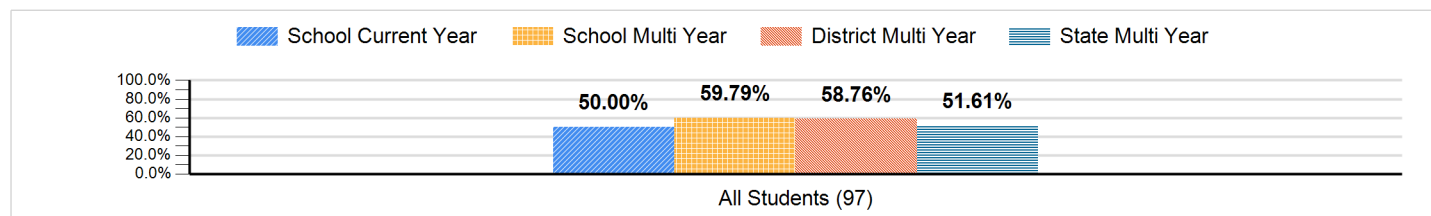
Student Population
