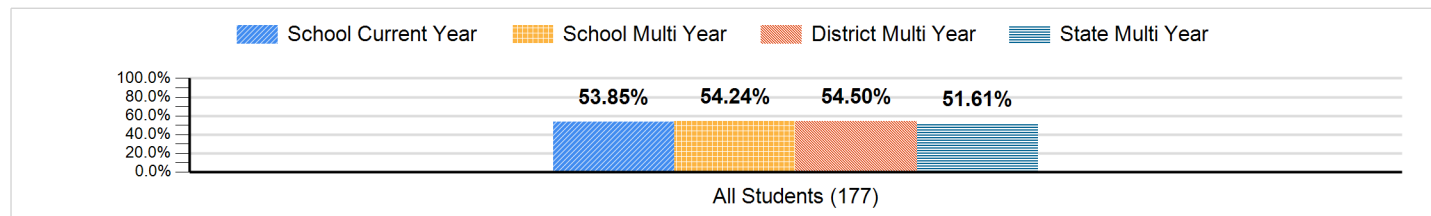
Student Population

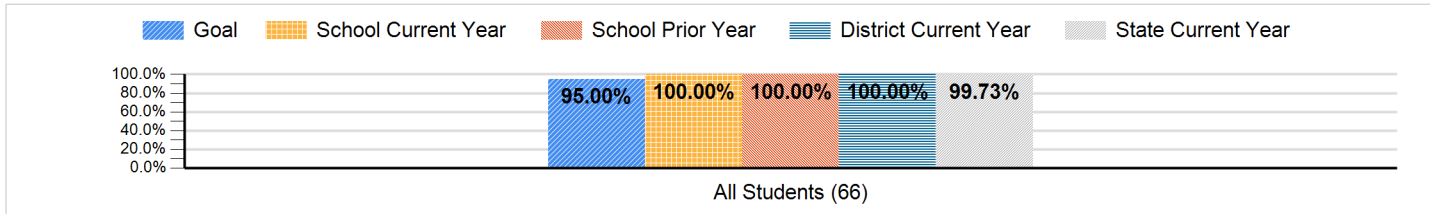

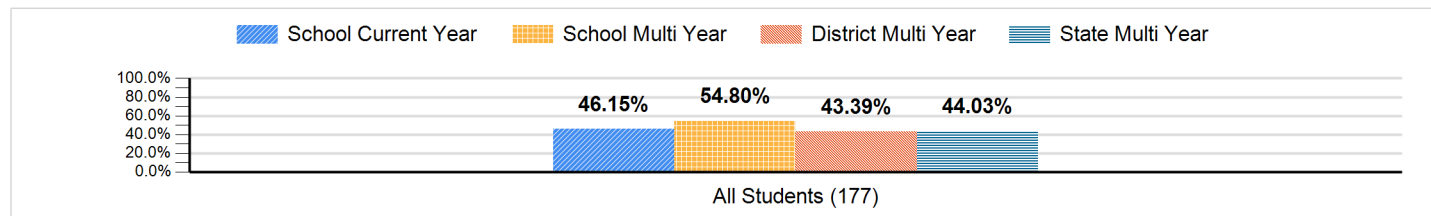

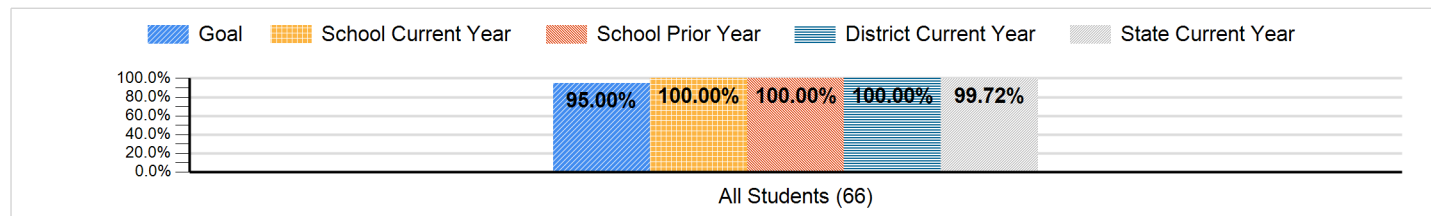

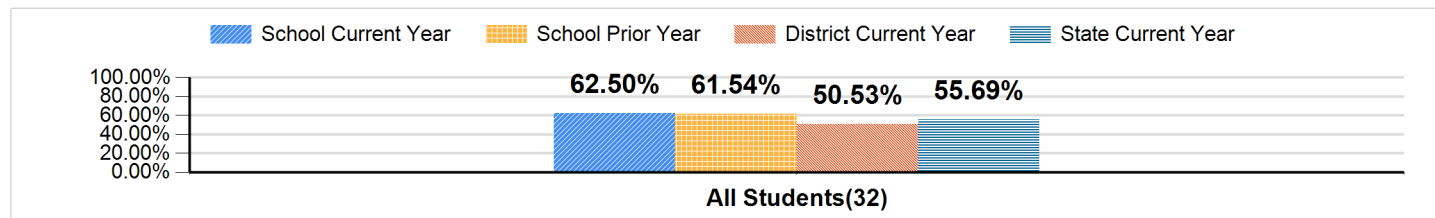
