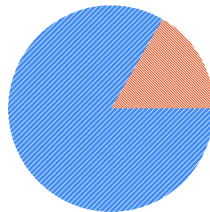

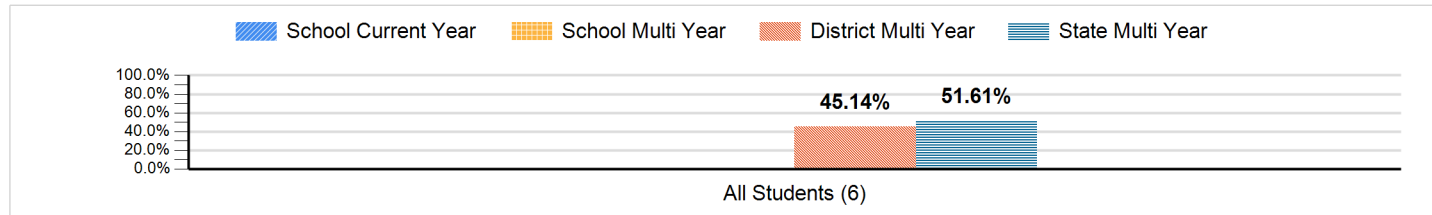
Student Population

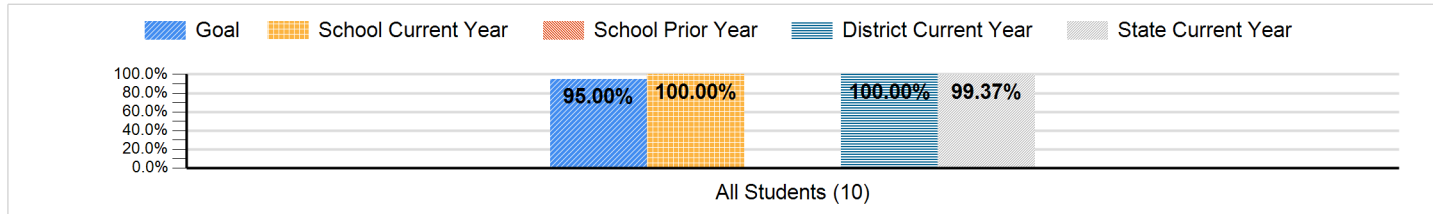

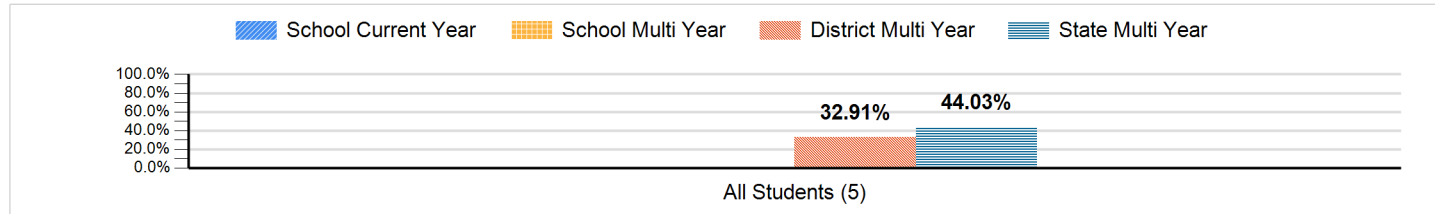

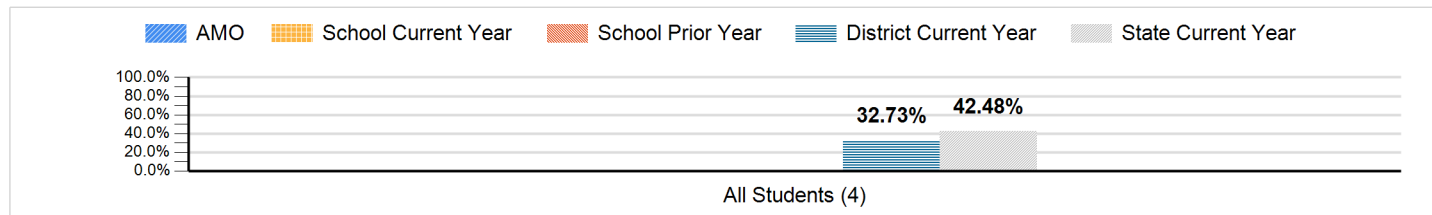

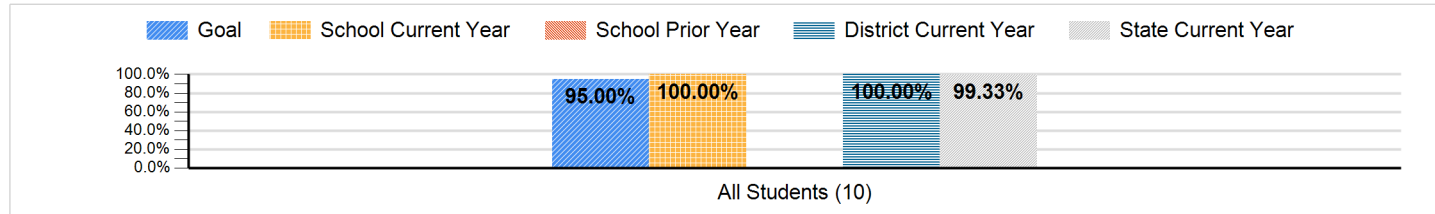

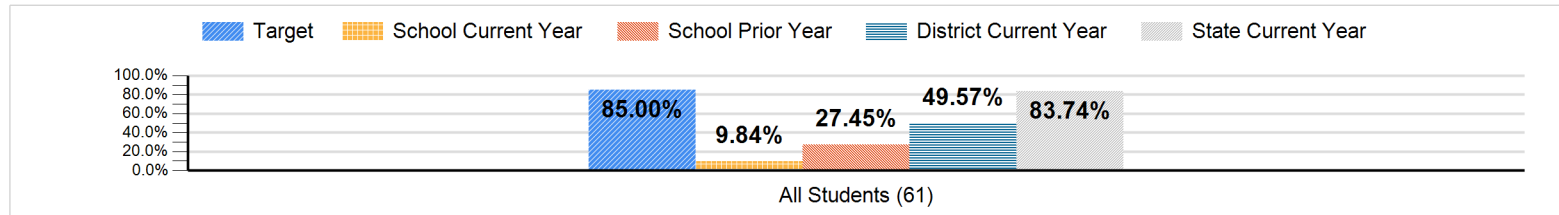

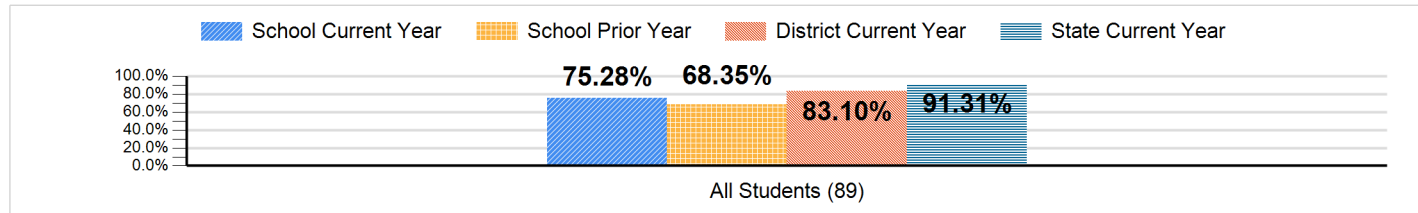
