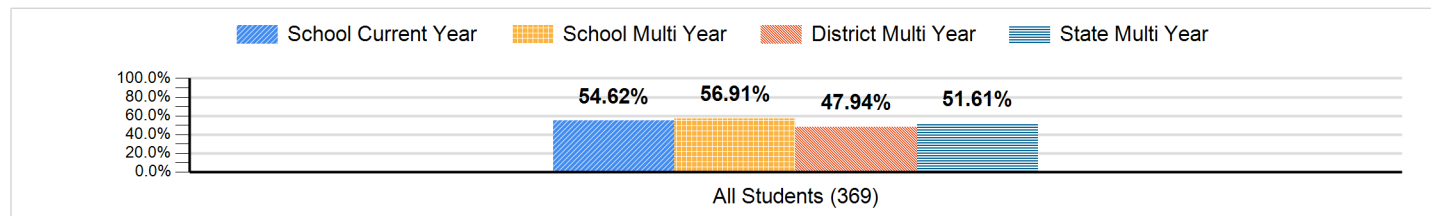
Student Population

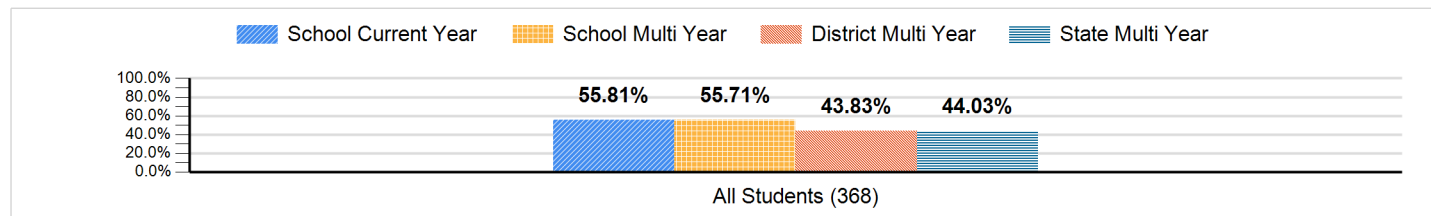

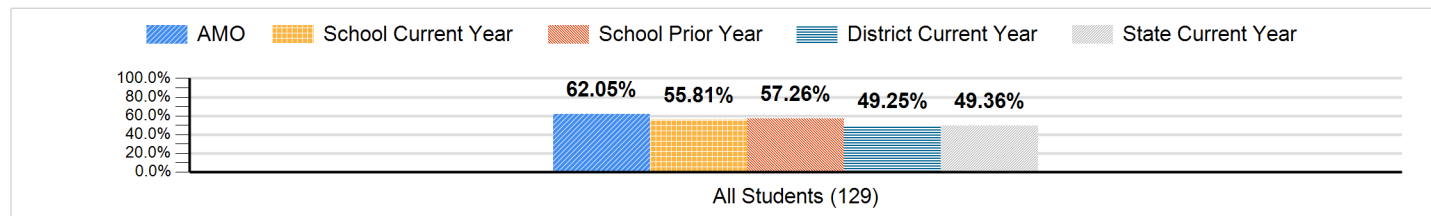

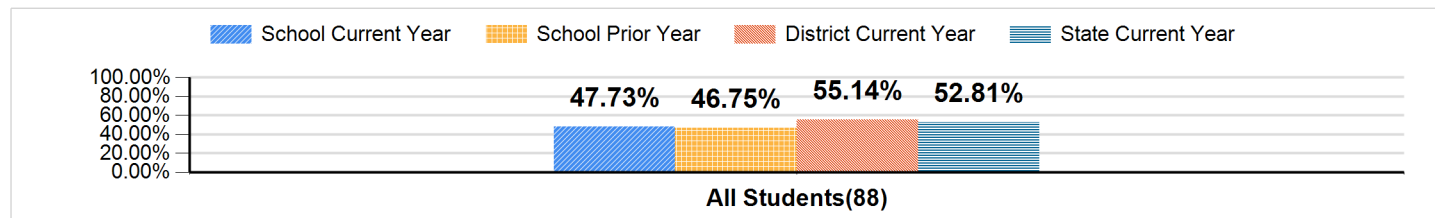
