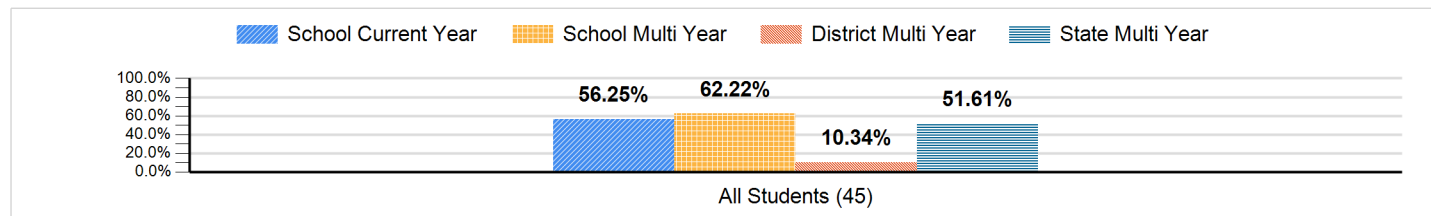
Student Population

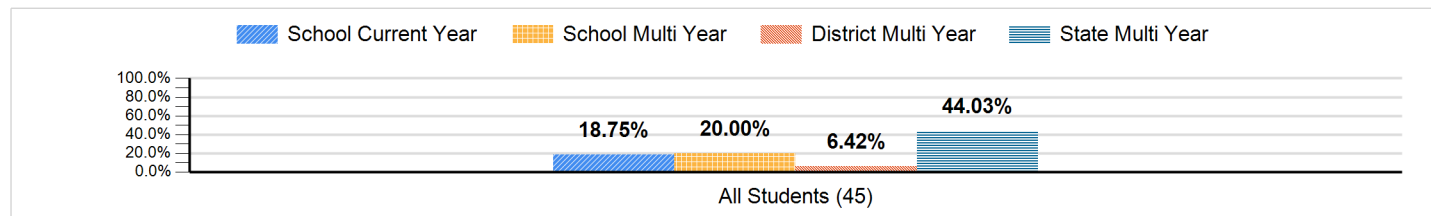
