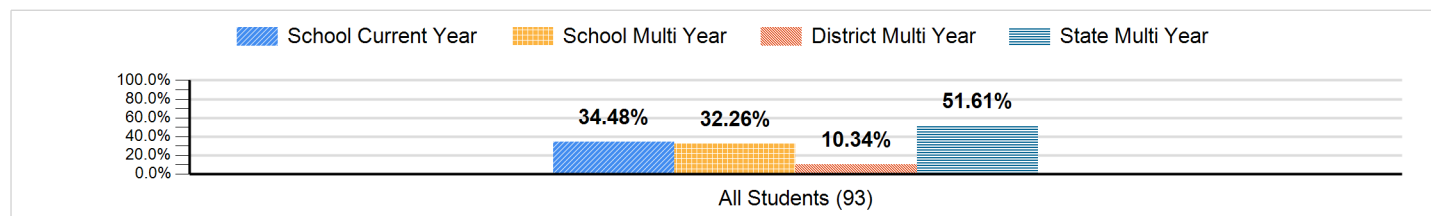
Student Population
