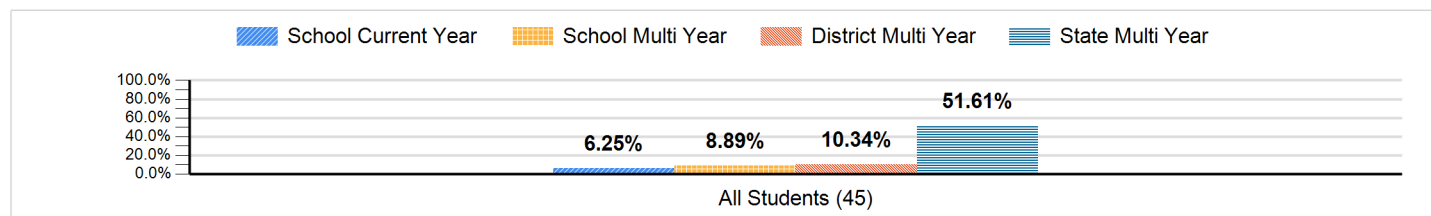
Student Population

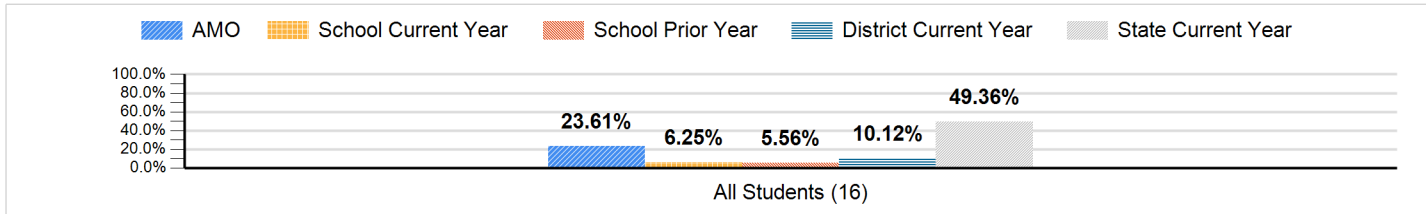
