#### All Program Reminders or Updates:

**Update iCAN Applications:** Has your organization had any recent staffing changes? If so, please update your iCAN application! This ensures inactive staff are removed and communications reach the right people. After making updates, don't forget to submit the application for approval so we can process the changes.

**iMATCH User Updates:** Along with iCAN applications, the iMATCH system also needs to be updated as staff changes. Please remember to contact CANS when changes occur and request an iMATCH form to add/remove users to keep records up to date.

**Claim Reminder for All Child and Adult Nutrition Programs:** Don't forget to submit your monthly reimbursement claims! All claims must be submitted by the 10<sup>th</sup> of each month to ensure timely processing and payment. Late submissions may result in delayed reimbursement, so please plan ahead and submit on time.

## Child and Adult Care Food Program (CACFP) Reminders or Updates:

### **CACFP 06-2025 – Feeding Infants and Meal Pattern Requirements in the CACFP; Questions and Answers**

- April 25, 2024, The USDA Food and Nutrition Service (FNS) published the final rule, “Child Nutrition Programs: Meal Patterns Consistent with the 2020-2025 Dietary Guidelines for Americans” (89 FR 31962), to better align program nutrition requirements for consistency with the goals of the most recent edition of the Dietary Guidelines. [2020-2025 Dietary Guidelines](#).
- The final rule went into effect on October 1, 2025, which limits the amount of added sugars in cereals and yogurts. [CACFP 07-2024](#).
  - Breakfast cereals must contain no more than 6 grams of added sugars per dry ounce (7 CFR 226.20(a)(4)(ii))
  - Yogurt must contain no more than 12 grams of added sugars per 6 ounces (2 grams of added sugars per ounce) (7 CFR 226.20(a)(5)(iii)(B)).

## School Nutrition Program (SNP) Reminders or Updates:

**Net Cash Resources:** This is a reminder that Net Cash Resource (NCR) letters requesting corrective action plans that were sent out in December for the 5-month limit are due tomorrow, Friday, January 9. Additionally, we noticed several sponsors exceeding the 3-month NCR limit this year. As we transition back to the 3-month limit next school year, we strongly encourage you to calculate your current NCR now. If your balance is above the allowable limit, please begin planning to spend down funds appropriately to remain in compliance. Notices will be sent to schools exceeding the 3-month limit; however, no action will be required at this time. If you have questions or need assistance with calculations or allowable expenditures, please reach out.

**On-Site Monitoring:** School Food Authorities (SFAs) with more than one school site must complete an on-site review of meal counting and claiming systems each school year before February 1. This review is required for all schools operating the National School Lunch Program (NSLP) and at least 50% of schools operating the School Breakfast Program (SBP). Each on-site review must ensure the school’s claim is based on the counting and claiming system, as approved by CANS in the annual application, and yields the actual number of reimbursable free, reduced price, and paid meals, respectively, served for each day of operation. If issues are identified, corrective action must be implemented, and a follow-up review must be completed within 45 days to confirm resolution. If you haven’t completed your [on-site monitoring](#) yet, be sure to do so as soon as possible.

**Fresh Fruits and Vegetable Program (FFVP):** This is a friendly reminder to ensure you are utilizing your FFVP funds and submitting claims through iCAN. Should you require assistance with this process, please do not hesitate to reach out. Additionally, now is an ideal time to review your fund balance and plan for expenditures for the remainder of the school year.

**Schools with FSMCs:** For schools with Food Service Management Companies (FSMCs) contract that are ending this year and those schools who may be considering bringing on an FSMC, Request for Proposal (RFP) season is just around the

corner. We are in the process of reviewing the RFP Template, FSMC Contracts and Renewal packets for updates. Look for more information to come in the next few weeks.

## **USDA Foods in School/Food Distribution Program Reminders or Updates:**

**USDA Foods Pre-Survey.** The Pre-Survey link was emailed to all schools yesterday. This quick, five-minute Microsoft Forms survey lists USDA Foods for the 2026–27 school year. Your responses will help determine which items appear on the Annual Survey in iCAN this February. Please complete it when you can—your input matters.

**DoD FFAVORS Reminder.** Please ensure you receipt your DoD Fresh/FFAVORS orders within two days of delivery. USDA is monitoring schools that miss this step, so timely receipting is essential.
