All Program Reminders or Updates:

- **iCAN Single Sign On:** Please log in to check that your Single Sign On login works properly. Common problems:
 - Forgotten password linked to the Single Sign On. Fix reset your password.
 - It takes you to a blue page with an error message at the bottom.
 - Is the email in the error message the same as the email associated with your iCAN?
 - Clear your cache and cookies, refresh the iCAN page and try to sign in with correct email
 - Try signing in using the Google Chrome browser.
 - Use an incognito window and try signing in again.
 - Still can't sign in, give CANS a call!
- Update iCAN Applications: Has your organization had any staffing changes recently? If so, please don't forget to update the iCAN application! Making these updates informs our office to remove inactive staff's access to iCAN and helps ensure that our office communications are sent to the correct people!
 **If any changes are made to the application, please don't forget to submit the application for approval so our office can approve the changes!
- Grab and Go (aka Non-Congregate) Summer Meals in Rural Areas for Seamless Summer Option (SSO) and Summer Food Service Program (SFSP)
 - All sponsors interested in operating a Grab and Go site should contact the CANS office no later than the end of February to ensure we can approve the new sites in time for summer operations.
 - In addition, all sponsors interested in operating a grab and go will need to sign up for the in-person SFSP New Sponsor & Grab and Go Training.
 - USDA has released two new memos to clarify information on the Grab and Go meals option since the Interim Final Rule was published on 12/29/2023.
 - Memo SFSP 04, SP06-2024 to use the grab and go meals option, a sponsor must be identified as rural or fall within a rural pocket. This memo outlines the data sources that can be used to determine if a site is considered as rural.
 - Memo SFSP 03, SP 05-2024 This memo outlines the differences in the interim final rule versus previous regulations and guidance provided for summer 2023 grab and go operations.

• USDA CEP 101 Webinar:

- September 26, 2023, FNS published a final rule, *Child Nutrition Programs: Community Eligibility Provision-Increasing Options for Schools*, with an effective date of October 26, 2023. The final rule lowered the minimum Identified Student Percentage (ISP) threshold from 40 percent to 25 percent. As a result, more students, households, and schools have the opportunity to experience CEP's benefits, such as increasing access to school meals at no cost, eliminating unpaid meal charges, minimizing stigma, and streamlining meal service operations. FNS is hosting webinars to provide an overview of the Community Eligibility Provision for interested School Food Authority staff.

USDA Foods in School/Food Distribution Program Reminders or Updates:

- March Order Form Open: The order form for March delivery opened this morning. The order form will close at 9:00 am on Thursday, February 8th. There are numerous bonus products available on the order form. Bonus products do not use entitlement but need to be recorded as part of your inventory. If you do not have entitlement available and would like to order processed items, contact me Darcy Beougher at <u>darcy.beougher@state.sd.us</u>. Processed items are state approved and have formulation statements and/or CN labels.
- USDA Food Deliveries: Just a reminder, USDA Foods delivery drivers do not have the authority to give away any food that has not been order by your SFA, this includes any foods that the driver deems as being "free." The product is not free and is most likely the result of a mis-picked item and is to be delivered to another school. If offered by the driver, please kindly decline.
- 2024-2025 School Year Annual Surveys: The annual surveys for the 24-25 school year will be opening on Wednesday, February 7 at 9:00 a.m. and close on Friday, February 23 at 9:00 a.m. The annual surveys give the state valuable school district information such as how much your district wants to spend in DoD Fresh/FFAVORS in the 24-25 school year and how many pounds you want at a processor. If your district utilizes bulk pounds, the 24-25 school year processing calculators have been added to the CANS website at this link <u>https://doe.sd.gov/cans/calculators.aspx</u>. It is important for schools to complete these surveys. - If you receive damaged or spoiled product from DoD Fresh/FFAVORS, contact the vendor and a DLA representative immediately. The vendor has the option to pick up the product.
