- Annual Training Requirements Reminder. CACFP training requirements must be completed by September 30<sup>th</sup> each year. We are encouraging agencies to continue to complete their required training throughout the year to avoid missing the deadline. Once you have completed the training you will also need to complete and pass the associated quiz to receive credit for taking that training. Please remember to print and save your training certificates for documentation.

## **School Nutrition Program (SNP) Reminders or Updates:**

- **FSMC Contracts (Quanna):** The FSMC Request For Proposals have been emailed to the schools requiring a new contract in SY25-26. If you are expecting to receive one and haven't or would like to bid a new contract before the requirement, please let CANS know and we will get one to you right away.
- Equipment Grant Deadline Reminder (Quanna): Reminder the deadline to have equipment grant applications postmarked is 2/14. We will begin reviewing submitted applications shortly after that and will make notifications likely early mid March.

- Community Eligibility Provision (CEP) (Andrea): If you want to learn more about CEP and how to apply you can access the CEP Timeline and iMATCH Basics webinar on the <u>DOE Online Learning Platform</u>. This webinar discusses the basics of Community Eligibility Provision (CEP), a timeline to follow if you are interested in applying, and some of the basic functions of the iMATCH system. You must enroll in the School Nutrition Course to access this training.
- Fresh Fruit and Vegetable Program (FFVP) (Diana W): This is a friendly reminder to ensure you are utilizing your FFVP funds and submitting claims through iCAN. Should you require assistance with this process, please do not hesitate to reach out. We are more than happy to support you. Additionally, now is an ideal time to review your fund balance and plan for expenditures for the remainder of the school year. We will be contacting schools that have large remaining balances of their allocated funds. If you know that you won't be able to spend your funds by the end of the school year, please contact our office for some options.
- **Get ready for School Breakfast! (Melissa):** National School Breakfast Week takes place from March 3-7 this year. The theme for this year is <u>Clue Into School Breakfast</u>. This theme adds an element of fun and excitement by bringing the thrill of mystery-solving to the cafeteria. This week highlights the importance of a healthy breakfast to help students succeed. Use this time to celebrate the National School Breakfast Program and the many ways it helps give kids a strong start each day.
- On-Site Monitoring (Melissa): School Food Authorities (SFAs) with more than one school site must complete an on-site review of meal counting and claiming systems each school year before February 1. This review is required for all schools operating the National School Lunch Program (NSLP) and at least 50% of schools operating the School Breakfast Program (SBP). Each on-site review must ensure the school's claim is based on the counting and claiming system, as approved by CANS in the annual application, and yields the actual number of reimbursable free, reduced price, and paid meals, respectively, served for each day of operation. If issues are identified, corrective action must be implemented, and a follow-up review must be completed within 45 days to confirm resolution. If you haven't completed your on-site monitoring yet, be sure to do so as soon as possible.
- Local Wellness Policy and Triennial Assessment (Susan): Sponsors participating in the National School Lunch Program (NSLP) and/or School Breakfast Program (SBP) are required to have a local wellness policy, which guides efforts to create a healthy school environment. Schools are responsible for developing, implementing, and evaluating their policies to address their unique needs. A triennial assessment is required every three years to review compliance and progress, with proper documentation of the process. To support compliance, we recommend using our state agency's triennial assessment form. Additional wellness policy resources are available on the <a href="CANS website">CANS website</a> under School Meals Program Requirements and through the <a href="USDA">USDA</a>.

  show active sites until Summer Feeding begins.

### **USDA Foods in School/Food Distribution Program Reminders or Updates: (Darcy)**

- The Annual Survey's are now open in iCAN. Districts have until Friday, February 21<sup>st</sup> to complete the surveys. There are 4 annual surveys to complete. Participation isn't required for the surveys but if schools want DoD Fresh/FFAVORS entitlement for the 25-26 school year, the DoD Fresh/FFAVORS survey must be completed.
- **Fun Fact!** USDA Foods in Schools supports the American agriculture producers by purchasing 100% American grown and produced foods.

## Summer Food Service Program (SFSP) and SNP Seamless Summer Option (SSO) Reminders or Updates:

- Seamless Summer Option (Susan): This program is available to schools participating in the school nutrition programs. SSO is an extension of the National School Lunch and Breakfast Program designed for schools that wish to provide meals over the summer months to their communities, but do not want to change program operations to meet the requirements of the Summer Food Service Program (SFSP). If you are planning to operate the Seamless Summer Option, please reach out to CANS to update your application. If you need a refresher on SSO operations, you can access the training video available on our <a href="DOE Professional Learning Platform">DOE Professional Learning Platform</a>.
- **Fun Fact! (Darian):** Sponsors are encouraged to incorporate locally sourced foods into their meal programs. This not only supports local farmers and food producers but can also introduce fresh, healthy foods they may not typically encounter.
