Child and Adult Care Food Program (CACFP) Reminders or Updates:

Program Year 2024-25 Reviews: Review preparations are underway for this current program year. Child Nutrition Resources (CNR), our contract company, will be conducting the majority of CACFP reviews this year. Review notifications have been sent out for reviews conducted by both CANS and CNR. CNR will be in touch with the agencies they are reviewing soon if they have not been already.

School Nutrition Program (SNP) Reminders or Updates:

Team Nutrition's Offering Meats and Meat Alternates at School Breakfast: Team Nutrition's "Offering Meats and Meat Alternates at School Breakfast" training guide has been updated to be consistent with the Final Rule, "Child Nutrition Programs: Meal Patterns Consistent With the 2020-2025 Dietary Guidelines for Americans." The final rule allows schools the option to offer grains, meats/meat alternates, or a combination of both at breakfast. This 20-page training guide shows school nutrition professionals how to offer meats and meat alternates at school breakfast by providing menu planning ideas, crediting information, sample menus, and more. New Training Series: Team Nutrition is pleased to announce a new addition to the training series, **The Road to Successful Menu Planning for School Meals**, to help schools plan and implement menus that support updates to the school nutrition standards. The new 15-minute training covers identifying top sources of added sugars in your school menus!

This training series includes quarterly 1-hour live (and recorded) webinars co-hosted with the Institute of Child Nutrition, and short on-demand trainings. Both are designed to provide school nutrition professionals with quick tips, tools, and knowledge needed to meet the nutrition standards for added sugars and sodium and to help create a road map for successful school menu planning now through School Year 2027-2028.

The trainings above can count toward USDA Professional Standards for School Nutrition Programs, Key Area 1000: Nutrition and Training Topic 1100: Menu Planning. These trainings and more are also available at the Institute of Child Nutrition's iLearn portal and USDA's Professional Standards Training Database.

Produce Safety University 2025: Child and Adult Nutrition Services is now accepting nominations for the FY 2025 Produce Safety University PSU includes a combination of classroom training, laboratory instruction, and field trips. Previous classes have visited fresh-cut processing facilities, produce distributors, a terminal market, and farms. Farm to School is integrated into classroom lectures and discussion throughout the course. You are encouraged to nominate participants who train school nutrition staff at the district level and/or produce procurement responsibilities. Participants will be expected and encouraged to teach others about produce safety using the training materials provided through PSU. Weeklong sessions will be offered during March, April, May, and June. Nominations are due via this DOE CANS Produce Safety University Nomination Form - 2025 by December 13, 2024.

Net Cash Resources (NCR): This school year, if your school exceeded a five-month net cash resource limit (based on SY 2023-24 financials), your district will receive a letter that will require you to create a spend down plan. Attached to that letter will be a financial spend down plan worksheet, a NCR calculation, and a list of common allowable and unallowable costs. These documents can assist you with creating a spend down plan that meets your program needs and follows federal program requirements. If your district does not receive a letter, that means your district does not need to submit a spend down plan this school year. As a reminder, DOE will allow schools to use a temporary flexibility for a two-year spend down plan.

USDA Foods in School/Food Distribution Program Reminders or Updates:

Pre-Survey: The Pre-Survey will be opening on January 8th, 2025. The Pre-Survey is a list of all USDA Foods the state can order for the 25-26 school year. An email will be sent to the program, billing, and ordering contacts for your agency on Wednesday, January 8th, 2025, with a Microsoft Forms Survey link to complete the yes or no Pre-Survey. Check with all Food Distribution Contacts to see who is completing the survey. The majority of USDA Foods selected on the Pre-Survey, will be placed on the Annual Survey released in February.

Entitlement Updated: USDA has reconciled the Total Lunches Served for school year 23-24. If your school district's Total Lunches Served increased in the 23-24 school year, there will be an increase in your school district's 24-25 entitlement. iCAN has been updated to reflect the reconciled Total Lunches Served. Call the Food Distribution Office with any questions.

Make sure to receipt your DoD Fresh/FFAVORS order within 7 days of your delivery and your USDA Foods delivery within 5 days of delivery.


