Permanent Agreement for all Child Nutrition Programs. On November 20, 2025, an email was sent to all Child Nutrition Program operators regarding a new permanent agreement. Updates have been made to the agreement including regulatory updates and combining the agreement for all programs. Please read through the updated agreement and send a signed copy back to CANS at DOE.SchoolLunch@state.sd.us no later than January 16, 2026.

Frequently Asked Questions and Tips for the Permanent Agreement Update:

- Your agencies' Authorized Representative (AR) or Superintendent must sign this agreement. You can find the AR in your iCAN application.
- The document must have a wet signature, and all pages must be scanned or faxed back to CANS.
- You can find your agreement number in your iCAN application
- If you are unsure which programs you are operating, reach out to CANS and we can help you. You can also find this information in your various iCAN applications.
- If you are in the process of adding a program, you will sign an updated permanent agreement once that program application is approved. Please do not include that program on this agreement.
- This agreement does not need to be approved by your agencies board, but it wouldn't hurt to share it with them.

Program Year 2025-2026 Reviews. Review preparations are underway for this current program year. CANS staff will be conducting a majority of the CACFP Reviews this year, while Child Nutrition Resources (CNR), our contract company, will be conducting only a hand full of CACFP reviews this year. Sponsors will be contacted to establish when the on-site review will take place.

School Nutrition Program (SNP) Reminders or Updates:

December Kitchen Counter Conversations. *Mastering the USDA's Food Buying Guide's Tools*. Dec. 16 at 2pm CST / 1pm MT. This session will highlight the updated Exhibit A Tool and the Interactive Grocery List, both designed to support menu development, streamline ordering, ensure compliance, and make planning easier. Food Safety Plan. Checklist Requirements. In addition to reviewing and updating HACCP-based SOPs at the start of the school year, SFAs are required to complete the <u>Food Safety Checklist</u> regularly – at least once a month, or more frequently if serious food safety issues are identified. The food service director, site manager, or head cook may conduct these reviews. All completed Food Safety Plan Checklists must be kept for three years plus the current school year. The checklist, along with a summary of other <u>Food Safety Plan</u> requirements, is available on our website.

USDA Foods in School/Food Distribution Program Reminders or Updates:

January USDA Foods Order. There will be a limited amount of ground beef on the January order form that opens next week. **All schools will be limited to ordering 2 cases of ground beef**. We apologize for the inconvenience, but this ensures smaller schools have the opportunity to receive this product as well.
