**USDA Donated Foods Value:** The national average minimum value of donated foods, or cash in lieu thereof, per lunch under the NSLP (7 CFR part 210) and per lunch and supper under the CACFP (7 CFR part 226) shall be **30.00 cents** for the period July 1, 2022 through June 30, 2023. For the National School Lunch Program, the per meal rate used for entitlement calculation increased from \$0.3960 to **\$0.4300 for SY2022-23**.
