

## iCAN User ID Request Instructions

Complete **Sponsor/ Agency Name and 7-digit CANS Agency Number**. This is your Local Education Agency or School Foodservice Authority name and number that is listed on your annual application/ agreement with CANS.

**Part 1:** The person who needs iCAN access (iCAN User), a change to their current rights, or a change to their contact information completes and signs this section.

### In the Box:

- **New User:** Does this individual replace another iCAN user who no longer needs access to iCAN for your sponsor/ agency? Select either: No or Yes. If yes, please record the first and last name of user to inactivate. The Authorized Representative must sign Part 2 Question 5.
- **Change to Current Users Access:** Record the email of the individual needing updated access.
- **Change to Current Users Contact Information:** User only needs to complete Part 1 of the form and the Authorized Representative must fill out Part 2.

### 2. User Role:

- *Authorized Representative:* The person in charge that has authority to run and sign for the selected program. **Must be an employee of the organization (receives a W-2).**
- *Claim Representative:* The person in charge of submitting the monthly claims for the selected program. **Must be an employee of the organization (receives a W-2).**
- *Food Service Manager:* The person in charge of running your food service program. This is usually the lead person in the kitchen.
- *Other:* Please indicate the position. For example: back up Claim Rep, back up Authorized Rep, back up to FDP ordering.

- **Is the user an Employee of the Sponsor / Agency?**
- **Is this user classified as an employee of the Sponsor / Agency?** Only employees that work for and are paid as an employee of the Sponsor / Agency may be granted full access in iCAN to Add / Modify.
- **Does this user work for a Food Service Management Company?** FSMC staff may be allowed access to order USDA Foods. No other access is allowed.
- **Does this user work under contract, or some other temporary association?** Contracted staff iCAN access may be granted view only access. Contractors may not have access to Add / Modify.
- **Is this user a Volunteer?** Volunteers are not allowed access to iCAN.

6. **Signature:** A wet signature is required on the paper; **a typed written name or electronic signature will not be accepted.** A scanned copy of this signed document submitted to CANS is acceptable. By signing this form, you agree that your iCAN account will not be shared with others.

**Part 2:** This section is filled out by your current Authorized Representative, or a person in a position with the highest authority at your sponsor / agency.

**Select Programs** that the user in Part 1 will need access to. Check only the program(s) that are currently operated.

1. **School Nutrition Programs (SNP):** For schools and non-profit agencies that operate the National School Lunch Program, School Breakfast Program, Special Milk Program, Fresh Fruit and Vegetable Program, and or the Seamless Summer Option.

2. **Child and Adult Care Food Program (CACFP):** This is for day care center, sponsors of family and group day care homes, and adult day care centers.
3. **Summer Food Service Program (SFSP):** This is for schools and non-profit agencies that operate the Summer Food Service Program.
4. **Food Distribution Program (FDP) – distributes USDA Foods:** Any school or agency on the School Nutrition Program (SNP) is eligible to participate in the Food Distribution Program.

Select the security access for the user listed in Part 1.

**For CACFP, SNP or SFSP:**

- **Add/ Modify Applications and Compliance Reviews:** This is the annual application/ agreement with CANS for the programs selected in Part 2. Selecting this will allow the user to add and change the annual application. It also allows the user to add/ modify Compliance Reviews.
- **Add/ Modify Provider Applications:** This only applies to CACFP Day Care Homes and allows access to add and change provider applications.
- **Add/ Modify Compliance Reviews only:** This allows the user to add and change the compliance review for your sponsor/ agency.
- **View Only for Applications:** This is your annual application/ agreement with CANS for the programs selected in Part 2. Selecting this will allow the user to view, but not make changes to your annual application.
- **Add/ Modify Claims:** This is your monthly claim for reimbursement for the programs selected in Part 2. Selecting this will allow the user to add and modify your monthly claims for reimbursement.
- **View Only for Claims:** This is your monthly claim for reimbursement for the programs selected in Part 2. Selecting this will allow the user to view, but not make any changes to your monthly claims for reimbursement.

**For FDP:**

- **Full Access:** This allows access to place orders, complete food survey, and print invoices.
- **View Only for Business Managers:** This allows access to view orders and surveys, allows the ability to print invoices and year end reports.
- **View Only for Invoices:** This allows access to view and print invoices.

**Please Note:** the FDP contact information must be updated if your sponsor/ agency has a new contact for Program, Ordering, Billing, or Warehouse duties. **Only one name can be listed as a contact for each position**, by selecting one of these positions you are replacing another contact at your school.
