

STATE AGENCY ADMINISTRATIVE REVIEW SUMMARY

The federal regulations require a minimum of 3/4 cup of vegetable to be offered each day for grades K-5. This requirement was not met on Wednesday & Friday, with only 1/2 cup offered. Increase the serving size of the carrots served on Wednesday & the chateau vegetables on Friday to 3/4 cup to meet the daily vegetable requirement of 3/4 cup total vegetables. 2)
