Effective May 28, 2023, according to ARSD 24:28:09:49, a school partner employing an individual with an advanced student teacher permit applicant shall:

- (1) Verify the applicant has a valid advanced student teacher permit;
- (2) Document that the school attempted but was unable to hire a teacher with a professional or advanced teaching certificate prior to hiring an applicant with an advanced student teacher permit;
- (3) Provide board minutes of approval for hiring a student teacher holding the advanced student teacher permit as a teacher of record;
- (4) Provide a cooperating teacher for the candidate to assist with academic and classroom management support through regular meetings;
- (5) Provide assurances of regular observation, guidance, and evaluation of assigned duties by the building principal;
- (6) Report the approved student teacher in the Personnel Record Form;
- (7) Provide monetary compensation to the student teacher, as the individual is serving as a teacher of record;
- (8) Offer enrollment in a mentoring program; and
- (9) Provide the student teacher with information about the SD Code of Professional Ethics for Teachers

We, the school partner, understand that the:

- maximum length for advanced student teacher permit is one year;
- individual must adhere to the South Dakota Code of Professional Ethics for Teachers in chapter 24:08:03;
- individual may not teach grades or content beyond the endorsements listed on the certificate;
- individual must be working towards the completion of the educator preparation program requirements;
- this placement is contingent upon the student's educator preparation program's discretion in determining if the student is eligible for placement; and
- educator preparation program (EPP) is in control of the placement for a student teaching experience and the EPP provides the approval for a student teacher to receive an advanced permit.
