Eligibility

- South Dakota public, private, and home-schooled students in grades K-12.

Contest Age Groups

- Contest will be broken down into three groups K-5, 6-8, 9-12.
- Participating schools will select 2 from each group.

Suggested Topics

Topics for Grades K-8

- How should you treat others online?
- What information is safe to put on social media and what should you keep private?
- How should you handle unwanted attention or strangers online?
- How can you select a strong password and keep it secure?
- How can you handle cyberbullying?

Topics for Grades 9-12

- How can you preserve your online reputation or “digital footprint” on both social media and elsewhere on the Internet?
- How should you handle unwanted attention or strangers online?
- How can you select a strong password and keep it secure?
- Why is it important to keep your devices and software up to date?
- When is it safe to text and what information is safe to text?

Format

- Submissions: Original hand-drawn or electronically created.
- Hand-drawn submissions: Must be scanned.
- Text: Should be dark and large enough to read.
- Format: Either a full-page drawing or a 4-panel comic.

Cybersecurity Awareness

K-12 DRAWING CONTEST

Content Guidelines

- No Trademarked Images: Avoid using trademarked images or brands (e.g., Disney, Dell, Google, Twitter).
- No Identifying Information: Do not include the student's full name or age on the front of the poster.
- Minimal Adult Support: Adults can offer technical support but should not aid in the creative process.
- No Professional Assistance: Professional (paid) help is not allowed.
- Appropriate Content: Inappropriate or offensive language and images will result in disqualification.

Media and Presentation

- Accepted Media: Watercolor, pen and ink, crayon, chalk, or markers.
- Brightness: Brighter colors reproduce better when printed.
- Visibility: Light pencil marks won't show up well, and posters should be easy to see and read.

Submission Requirements

- Identifiable Information: Include the child's first name, age group, and district; home schoolers should list their city, instead of the district.
- Submission Deadline: All submissions must be made and submitted by May 1st.
- School Selection: Each school chooses their top 2 from each age group to submit.
- BIT/DOE personnel will select six posters from each group
- Final Selection: Six posters from each age group (K-5, 6-8, 9-12) will be presented to the Chief Information Security Officer for the State of South Dakota and the SD DOE Department Secretary for the final selection.


