

Post Funding Commitment Changes

After the Funding Commitment Decisions Letter is received, there are certain modifications that may be made to the approved funding by notifying USAC of the changes and obtaining approval. All of these changes must be submitted online in EPC. Most changes are made via the Form 500 "Funding Commitment Adjustment Request Form." The exceptions are the submission of a Service Substitution Request or a Service Provider Identification Number (SPIN) Change. These changes are also handled inside EPC but are not on the Form 500.

The summary of post FCDL changes that may be submitted and how to do so follows.

Form 500

The Form 500 is the “Funding Commitment Adjustment Request Form” and can be filed to accomplish one of the following:

- To adjust the funding year Service Start Date reported on a previously filed Form 486.
- To adjust the Contract Expiration Date listed on your Form 471 application.
- To request an extension of the service delivery and installation deadline for non-recurring services.
- To cancel irrevocably and totally a Funding Request Number (FRN).
- To reduce irrevocably the amount of a Funding Request Number (FRN). This is especially important for applicants that may not use all of their approved Category 2 funding. In order to recapture the funding and be able to reapply for it in future years, be sure to file Form 500 and return any unused funds to USAC. Applicants will need to provide additional information along with the Form 500 to identify exactly how much funding should be credited to each entity so that this money can be available for commitments in future years.

When to File

The Form 500 cannot be filed until USAC has issued a Funding Commitment Decision Letter (FCDL) for the FRN to be modified. The Form 500 should be filed as soon as the applicant is aware of new circumstances that require adjustment to one or more FRNs.

How to File

The Form 500 must be submitted in EPC.

Deadline

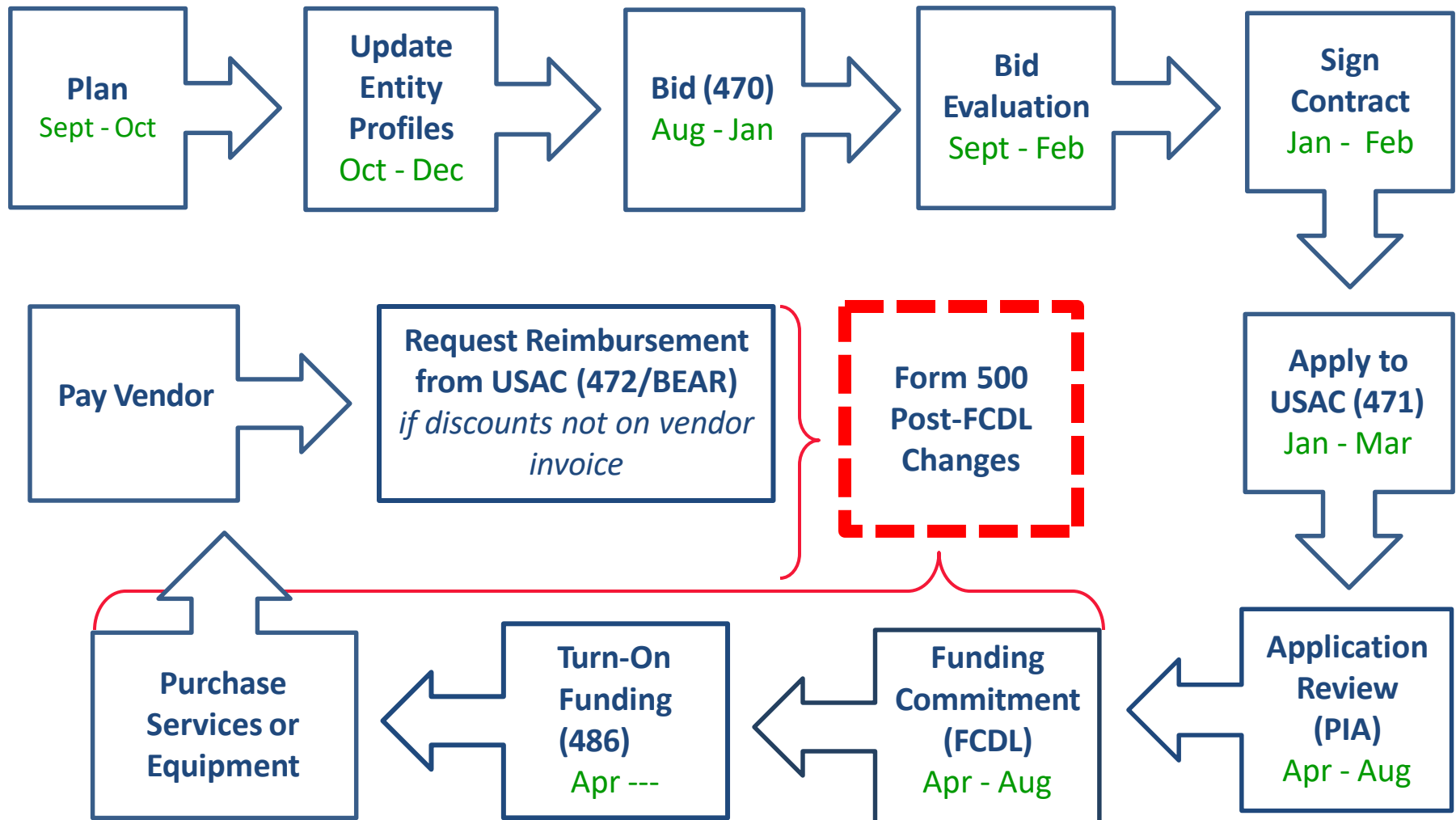
Changes that result from filing a Form 500 will affect other parts of the application process, so the Form 500 must be filed before those changes can occur.

USAC will issue an applicant version and a service provider version of the Revised Funding Commitment Decision Letter (RFCDL) in EPC after the form has been successfully processed.

What is the Form 500?

- Form 500 has 5 different purposes
- Only submitted when certain situations occur
- Only submitted post-funding commitment
- For FY 2015 and earlier, paper Form 500 must be completed and then uploaded into EPC as a customer service case

- For FY 2016 and later, the form must be filed in EPC
 - This Guide provides instruction on filing the Form 500 in EPC, although the paper form is very similar

When to File the Form 500

- Cannot be filed before Funding Commitment Decision Letter (FCDL) has been issued, but
- Should be filed as soon as new circumstances arise that require adjustment to one or more FRNs
- **Deadline for Service Delivery Deadline Extensions: On or before the original deadline, which is typically September 30**
 - No firm deadlines for other requests
 - Form 500 may need to be submitted to implement changes that will allow for processing of other forms
 - Example: returning C2 funding so \$ can be used for future FRN approval
 - Example: extending a Category 2 contract expiration date so USAC will pay invoices for equipment or services delivered and installed after the original contract expiration date

What Happens After Filing the Form 500?

- USAC may contact the applicant with any questions about the Form 500 submission
 - This often happens when FRN funding is reduced
- USAC will issue an applicant version and a service provider version of the Revised Funding Commitment Decision Letter (RFCDL) in EPC after the form has been successfully processed
 - Processing of Form 500's can take 6+ months
 - Can escalate with CSB after 90 days

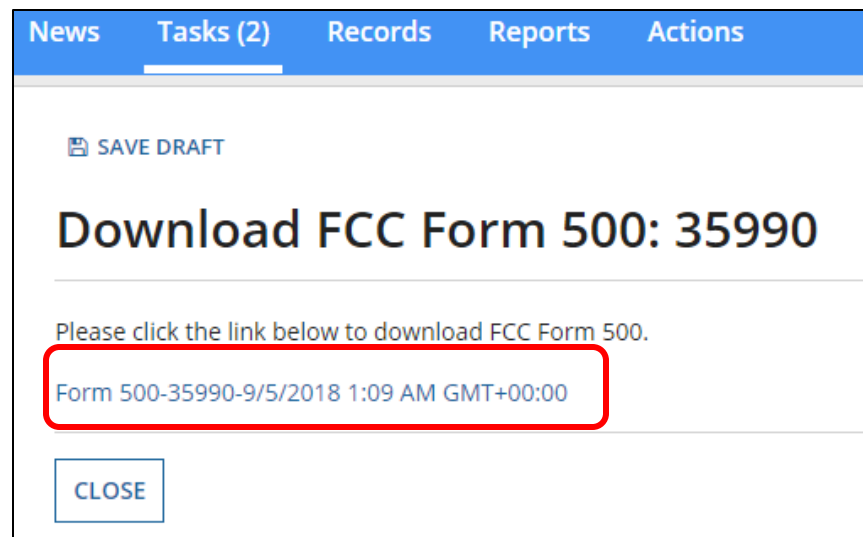
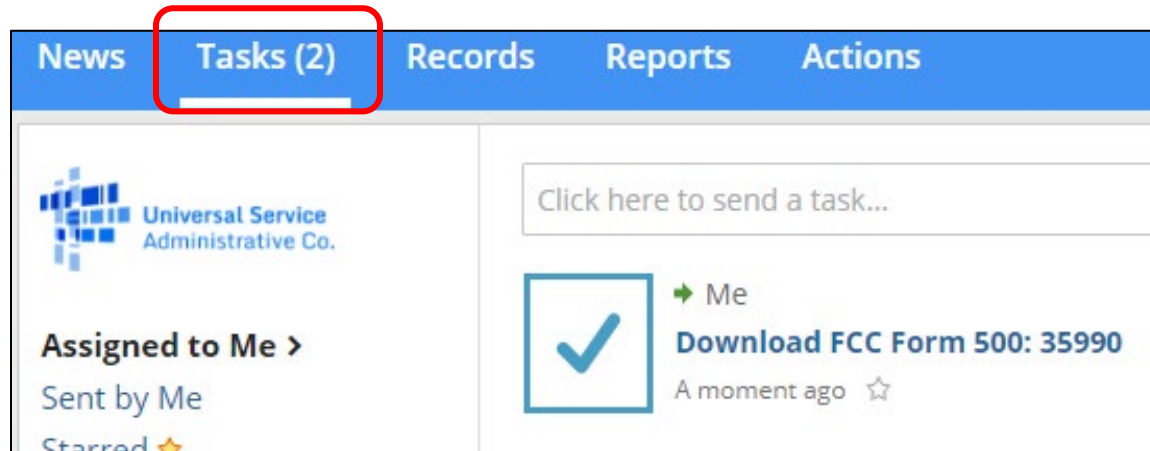

SPIN Changes - Overview

In certain situations, applicants and service providers can request a change of the Service Provider Identification Number (SPIN). This number is also known as the service provider's 498 ID. A SPIN change may either be a Corrective SPIN Change or an Operational SPIN Change.

Corrective SPIN Change

A corrective SPIN change is a notification to USAC that the SPIN associated with a Funding Request Number (FRN) is not correct. This occurs when:

- the applicant or USAC made a data entry error, or
- a change occurred that was not initiated by the applicant.

Corrective SPIN changes include the following:

- Data entry errors were made when the Form 471 was submitted. This includes entering the wrong SPIN on the Form 471 or entering the wrong SPIN because your service provider has multiple SPINs and you entered the wrong one.
- A merger or acquisition. The original service provider has merged with, or has been acquired by, another company and the SPIN indicated on the FRN has changed.
- Other instances when the SPIN indicated on the Form 471 changed when you did not initiate the change.

Corrective SPIN change requests must be submitted no earlier than the date of your Receipt Acknowledgment Letter (RAL)—unless you have been contacted by USAC for clarification about this application and typically must be submitted no later than the last day to receive service for the FRN. If you discover the need to submit the SPIN change after the last day to receive service, submit it as a customer service case with an explanation that the FRN does not appear in your EPC account. In any event, the very last day to submit the corrective SPIN change is the invoice deadline.

Operational SPIN Change

An operational SPIN change is a request to change the actual service provider associated with an FRN. The change in service providers is the result of a deliberate decision by the applicant.

Operational SPIN changes must be submitted no earlier than the date of your Funding Commitment Decision Letter (FCDL) and typically must be submitted no later than the last day to receive service for the FRN. If you discover the need to submit the SPIN change after the last day to receive service, submit it as a customer service case with an explanation that the FRN does not appear in your EPC account. In any event, the very last day to submit the corrective SPIN change is the invoice deadline.

USAC will not process requests for pre-commitment operational SPIN changes.

NOTE: Applicants who file SPIN change requests must still comply with the deadlines for the Form 486. If the SPIN change is being submitted near the invoicing deadline date, the applicant may want to request an invoice deadline extension request (IDER). This will extend the invoice deadline while the SPIN change is being reviewed and processed.

Corrective SPIN Changes

A request to correct a Service Provider Identification Number (SPIN) is a request to change a SPIN that usually does not change the actual service provider. There are three categories of SPIN corrections that the USAC will consider upon written request.

Category #1 - USAC or the applicant made a data entry error

If a service provider or SPIN is incorrectly named or indicated in a Receipt Acknowledgment Letter (RAL) or a Funding Commitment Decision Letter (FCDL), the USAC will correct the SPIN upon written request and verification. This includes situations where the right company was named, but the wrong SPIN associated with that company was indicated.

SPIN corrections cannot be used in a situation where the original Funding Request Number (FRN) was denied; denials have to be addressed through the Appeals process.

Category #2 – Original service provider changed its SPIN due to a merger or acquisition

If a service provider's SPIN has changed due to the merger of companies or the acquisition of one company by another, USAC will make the correction upon written request and verification by the service provider. However, if the merger or acquisition will result in a change on some FRNs but not on other FRNs, the applicant must initiate the request.

Occasionally, the service provider does not initiate a global SPIN change. In this case, applicants can bring the situation to USAC's attention so that USAC can contact the service provider.

Category #3 - Other instances of a service provider indicating a change.

The service provider may also have indicated the change rather than the applicant.

How to Request a Corrective SPIN Change

A request for a SPIN correction (not substituting the actual provider of your service, but instead correctly identifying that provider) may be submitted while your application is under review or after commitment has been made.

1. To correct a SPIN While Your Application is Under Review

Applicants will receive RAL in their EPC News feed after filing the FCC Form 471. Corrective SPIN changes can be submitted through the RAL modification process while the form is still under review. RAL modifications are included in the documentation that your Program Integrity Assurance (PIA) reviewer uses to review your form.

To Submit a RAL modification:

- Search for your Form 471 from the FCC Forms and Post-Commitment Requests section at the bottom of your EPC landing page.
- Click on the application number to access your form.
- From the Related Actions menu at the top of the page, choose Submit Modification Request (RAL).
- Follow the prompts to access the fields appropriate to your request and provide the information about the FRN that requires correction.
- Provide the correct SPIN and service provider name and add a note identifying this as a corrective SPIN change.
- Specify the allowable correction category this change falls into. The allowable correction categories are:
 - Data entry correction;
 - Merger/acquisition correction;
 - Correction due to a change that was not initiated by the applicant.

A brief explanation should be provided of the circumstance requiring the change.

2. To correct a SPIN after a Funding Commitment Has Been Made:

Follow the SPIN Change guide and submit the request in EPC.

Operational SPIN Changes

Once an applicant conducts a Form 470 competitive bidding process, selects the most cost-effective vendor, and submits the Form 471, the applicant may not change to a different service provider unless all five of the following conditions are met:

- (1) The SPIN change is allowed under state and local procurement rules.
- (2) The SPIN change is allowed under the terms of any contract between the applicant and its original service provider.
- (3) The applicant has notified the existing service provider of the intention to change to a different service provider.
- (4) There is a legitimate reason to change providers (for example, breach of contract or the service provider is unable to perform the requested services).
- (5) The newly selected service provider received the next highest point value in the original bid evaluation. If the applicant did not receive multiple bids, the applicant must submit a statement explaining that it received only one or no bids.

Important: Changing service providers because the services are available at a lower cost from another provider or because you now wish to do business with a provider that did not originally participate in the competitive bidding process are not considered legitimate reasons for change, and requests citing such reasons will be denied.

When to file Requests

A request for an operational SPIN change for a Funding Request Number (FRN) must be received no earlier than the date of the Funding Commitment Decision Letter (FCDL) and no later than the last date to submit an invoice for that FRN.

USAC is concerned about its ability to pay the appropriate service provider depending on when service provider changes are made and when change requests are received and approved. If a service provider is changed before USAC approves a change request, there is a possibility that USAC will inadvertently pay the old service provider. To minimize that possibility, applicants should notify USAC of their intent to change service providers as soon as the decision is made and should advise USAC of the proposed effective date of the change.

In order to reduce confusion and possible delays, applicants should send the request for the change to USAC before the change takes place so that USAC has time to process the request before the submission of any invoices for services rendered by the new service provider. Once the request is received, USAC will make no additional payments on the FRN until the change is reviewed and either: (1) approved and the SPIN is changed, or (2) denied and USAC verifies that additional invoices are for services actually rendered to the applicant by the original service provider.

Split FRNs when New Service is Delayed

Split FRNs and SPIN changes are allowed when an applicant experiences a delay in receiving new service due to late provisioning or installation of the service by the new service provider. The applicant may request a SPIN change and allocation of funding back to the incumbent provider for the months in which new service was delayed. For example, if the new service provider cannot begin providing service until September 1, the applicant may request the funding for the months of July through the end of August to be split from the original FRN (which requested 12 months of funding with the new service provider) and for a new FRN to be created using the incumbent service provider's SPIN. The original FRN would then be revised to reflect funding for the period September 1 through the end of the funding year, with the new service provider's SPIN. Applicants conducting this type of operational SPIN change must remember to submit an additional Form 486 for the newly created FRN as soon as the RFCDL is received.

Applicants cannot increase the total amount of their funding request when the FRN is split between two vendors due to a delay in the installation of new service.

Operational SPIN Change Request Deadlines

A SPIN change request for a funding request (FRN) must be submitted no later than the invoice deadline for the FRN, and ideally on or before the last day to receive service.

Conditional Multi-Year Contracts

If the applicant wishes to switch service providers under a multi-year contract, it may switch to a multi-year contract with a new service provider without posting a new FCC Form 470 and waiting at least 28 days. Remember, however, that the requirements listed above for initiating an operational SPIN change still apply.

The multi-year contract with the new service provider must have an expiration date no later than the original contract's expiration date and must not exceed the contract duration listed in the original FCC Form 470 or the request for proposal (RFP).

Service Substitutions

Changing service providers does not allow applicants to also change the specific products or services to be supplied in their funding requests.

Applicants may make a simultaneous request for both service substitution and change in service provider by: (1) following the steps as outlined in the service substitutions procedure, and (2) including the nickname and identification number of the SPIN change request in EPC with the service substitution request.

In the event that a simultaneous service substitution and service provider change cannot be granted due to a problem with either request, USAC will contact the applicant to determine if USAC should continue to process the remaining request.

When to File Operational SPIN Change Requests

Best advice: Wait until the final invoice from the original service provider is received and then file the SPIN change. This way you will know exactly how much to tell USAC to allot to each vendor (FRN) during the split FRN process.

How to Apply for an Operational SPIN Change

Follow the SPIN Change Guide to submit the SPIN Change request in EPC. Note: If the SPIN change is requested after the last day to receive service, the FRN may not appear in EPC. If this should occur, the applicant should prepare their SPIN change request and submit it as a customer service case.

- SPIN Corrections
 - Changing a SPIN that usually does not change the actual service provider
 - Most commonly used when the wrong SPIN was entered on the Form 471 – sometimes happens when a vendor has multiple SPINs
 - Sometimes used when vendors merge, and the vendor has changed the SPIN
- SPIN – Operational Changes
 - Changing a SPIN when the actual service provider is changing
 - Most commonly used when a vendor cannot provide the service/equipment or has gone out of business
 - Can also be used where there has been a delayed installation of recurring service and two different vendors have provided service in the same funding year

When and Where are SPIN Changes Made?

- SPIN changes can be made the RAL Correction Process if they are discovered prior to funding commitment
 - See RAL Correction Process Guide
- After funding commitment, SPIN changes must be made in EPC using the SPIN Change Module
 - Access at the top right of the EPC Landing Page




- SPIN changes must be requested before the deadline to invoice for that FRN
 - Typically October 28 after end of funding year for recurring services
 - January 28 after end of funding year for non-recurring services

Service Substitutions

A service substitution is a change in the products and/or services specified in the Form 471. In certain limited circumstances, applicants or service providers may request and be approved for service substitutions. In addition, service providers or equipment manufacturers may submit "global" service substitutions if, for example, they want to replace a discontinued product with a new product across all funding requests.

The certifications and representations made in the original FCC Form 471 application apply to the service substitution request. False statements on a service substitution request carry the same penalties as those indicated in the FCC Form 471 certifications.

Service substitutions encompass changes in the technical components (whether products or services or both) specified in the Form 471 Funding Request. Applicants who file service substitution requests must still comply with the deadlines for the Form 486.

Service Substitution Criteria

Service or product substitutions must meet the following conditions as specified in the Federal Communications Commission (FCC) rules:

- The substituted services or products have the same functionality as the services or products contained in the original proposal.
- The substitution does not violate any contract provisions or state or local procurement laws.
- The substitution does not result in an increase in the percentage of ineligible services or functions.
- The requested change is within the scope of the establishing Form 470, including any Requests for Proposals (RFPs), for the original products and/or services.

If a service substitution results in a change in the pre-discount price for the supported service, E-Rate funding will be based on either the pre-discount price of the product or service for which support was originally requested or the pre-discount price of the new, substituted product or service, whichever is lower.

Example: USAC approves an applicant's request to use 87 six-port network modules at a pre-discount cost of \$8,700.00 instead of a different brand of 58 eight-port network modules that were originally approved in the applicant's FCC Form 471 at a pre-discount cost of \$10,000.00. In this example, the pre-discount cost would be reduced to \$8,700.00 as this is the lower price.

When to Submit a Service Substitution Request

Pre-Commitment: Submit the request via the RAL modification process. If USAC has not completed the services portion of its application review when the substitution request is submitted, then USAC will

include the substitution request in the review. The Funding Commitment Decision Letter (FCDL) includes a notation that USAC has incorporated the substitution request.

If USAC has completed the services portion of its application review, we will review and act on the substitution request separately.

Post-Commitment: If an FCDL has been issued, service substitution requests must be submitted in EPC using the service substitution request module found on the EPC landing page. Note: The Service Substitution Module in EPC is not intuitive and applicants often find it is easiest to complete a single line of the module, and then upload a "From-To" spreadsheet with their request to fully explain each FRN line item, what was originally approved and the cost, and what is being substituted and the cost.

Deadline: USAC must receive a service substitution request on or before the last day to receive service for that FRN. In general, the last day to receive service is:

Recurring services: June 30 (last day of the funding year)

Non-Recurring services: September 30 following the end of the funding year

However, the deadline for the receipt of non-recurring services may be extended beyond the June 30 (i.e., special construction services) or September 30 (i.e., other non-recurring services) deadlines. (Service delivery extensions are only available for non-recurring services/charges.) If the deadline for receipt of these services is extended, the deadline for the service substitution request is automatically extended as well.

How to Submit a Service Substitution Request

Applicants must submit service substitution requests in the E-Rate Productivity Center (EPC).

If a service substitution results in a decreased pre-discount price, the service substitution request will be considered a request for modification of the funding commitment, just as though the applicant submitted an FCC Form 500 (Funding Commitment Adjustment Request Form). Therefore, when USAC approves a service substitution request that includes a cost decrease, we will adjust the commitment for the affected funding request to reflect the decreased pre-discount cost.

Service Substitution Review

USAC's review includes an evaluation of whether "same functionality" is maintained between the original and proposed new configuration, and whether the new configuration is eligible for funding. For service substitution requests involving internal connections, USAC review may first evaluate the substitution based on the "Function" and "Product Type" for each line item in the "from" and "to" lists.

An Internal Connections service substitution request is deemed to meet FCC requirements for "same functionality" if the original and new configurations maintain consistent functions and the request does not change the type of service from one category to another.

For example, these service substitution requests meet the requirement for same functionality:

- A network switch for a network router (Function: "data distribution")

- A UPS for a tape backup (Function: "data protection")

USAC may only approve service substitution requests when FCC requirements for same functionality are met. USAC will respond in writing to the service substitution request, either approving the request or indicating the reason(s) why the request cannot be approved.

Service Substitution Corrections

If you need to make subsequent corrections to a service substitution, applicants and service providers must follow the normal service substitution procedures and timelines in order to obtain pre-approval of changes.

If USAC finds an unapproved change during the invoice review process, USAC may refuse to pay the invoice for products or services that were not originally requested. Furthermore, if, during an audit, USAC discovers different products or services from those approved, USAC may make a commitment adjustment and require that you return incorrectly disbursed funds.

If the applicant discovers that products or services delivered are different from those approved on the FCC Form 471, the applicant should file a correcting service substitution even if the discovery occurs after the last day to receive service. Late-filed service corrections must be filed using the Appeal Module in EPC instead of the Service Substitution Module because EPC will not permit such requests to be submitted after the last date to receive service. To ensure that a late-filed request is processed, applicants should prominently indicate that the request is a "correcting service substitution." However, applicants are strongly encouraged to file traditional and timely service substitutions when making changes in products and services whenever possible.

Transfer of Equipment

Recipients of E-Rate funding are expected to use all equipment purchased with E-Rate program discounts at the particular location, for the specified purpose, and for a reasonable period of time, as approved on the FCC Form 471 Funding Request Number. If an applicant wants to transfer equipment from the entities specified in the FCC Form 471 Funding Request Number (FRN) approved by USAC, the applicant needs to ensure that they transfer the equipment in a manner consistent with FCC rules.

Eligible products and services purchased with E-Rate program discounts cannot be sold, resold, or transferred for money or any other thing of value, with the following exceptions:

- Beginning January 3, 2011, applicants can dispose of, donate, or trade “obsolete” equipment for payment or other consideration. Obsolete equipment is defined as equipment that has been installed for five years or more (see FCC [10-175](#)). Applicants are not required to continue using the equipment after five years, nor are they required to dispose of such equipment five years after installation.
- Applicants may transfer equipment in the following situations, depending on whether the transfer occurred before or after July 1, 2021. In neither situation can the equipment be sold or transferred for money or anything of value, (unless it is “obsolete” as described above):
 - Transfers that occurred **before** July 1, 2021
 - Equipment may be transferred to other eligible entities three years after the purchase date.
 - Equipment may be transferred from a temporarily or permanently closed location to other eligible entities within three years of the date of purchase.
 - Notification of transfers must be submitted to USAC using the FCC Form 500
 - Transfers that occur **on or after** July 1, 2021
 - Equipment may be transferred to other E-Rate eligible entities within the same school district or library system.
 - Equipment may be transferred from a temporarily or permanently closed location to other eligible entities
 - Equipment transfers may occur without notifying USAC via the FCC Form 500. However, both the transferor and the recipient must maintain detailed records documenting the transfer and the reason(s) for the transfer for a period of five years after the transfer occurs.

Equipment Transfer Requirements

A transfer of equipment has occurred if the equipment provides services to entities that were not included in the original FRN. The table below summarizes the actions required for the specific period (within or after three years of purchase) depending on whether the equipment transfer took place before or after July 1, 2021. The equipment transfer rules apply to all Funding Years.

Equipment Transfer Requirements

A transfer of equipment has occurred if the equipment provides services to entities that were not included in the original FRN. The table below summarizes the actions required for the specific period (within or after three years of purchase) depending on whether the equipment transfer took place before or after July 1, 2021. The equipment transfer rules apply to all Funding Years.

	Time Period	Actions Required
Equipment Transfer before July 1, 2021	Transfer occurs within three years of purchase	Applicant maintains documentation and files an FCC Form 500
	Transfer occurs three years after purchase	Applicant maintains documentation and does not file an FCC Form 500
Equipment Transfer on or after July 1, 2021	Transfer occurs within or after three years of purchase	Applicant maintains documentation and does not file an FCC Form 500

Equipment Transfer Documentation Requirements

Both the transferor and recipient must maintain detailed records (e.g., a detailed fixed asset list or inventory records) documenting the transfer and the reason for the transfer for five years after the transfer occurs under FCC rules. The requirement to maintain equipment transfer records for five years does not affect the requirement that schools, libraries, and consortia maintain accurate asset and inventory records of equipment purchased, and the locations of such equipment, for a period of 10 years after purchase. Applicants are required to implement controls and procedures to ensure that equipment is transferred only to eligible approved locations. The detailed documentation information should include the following information:

- Equipment model, serial number, quantity installed
- Location in school or library where equipment was originally installed
- Location in school or library where equipment was transferred
- Date of installation/transfer
- Records of business reason for transfer
- FCC Form 500 supporting transfers within three years of purchase, if transfer occurred before July 1, 2021
- Operating status of funded equipment
- Information demonstrating that the equipment was operational and connected

Tips to Avoid Common Pitfalls

- Remember to file the FCC Form 500 for equipment transfers that occurred prior to July 1, 2021.
- Ensure the equipment is properly installed, secured, and operational.
- Maintain an updated asset register including make, model, serial number, FRN, installation date, and location for all E-Rate funded equipment for a period of 10 years after purchase.
- Update your asset register when equipment is replaced for warranty purposes.
- Label your E-Rate equipment to make it easy to find.
- Keep complete documentation of all transfer(s) and ensure that the recipient is also E-Rate eligible.
- Perform regular inventory audits.
- Maintain all documentation related to the application for, receipt, and delivery of supported services for 10 years after the latter of the last day of the applicable funding year or the service delivery deadline for the funding request.

Equipment Trade-Ins

Equipment purchased with E-Rate program funds can also be traded in, but no sooner than five years after the equipment is installed. Trade-ins are not allowed before the five-year period has elapsed.

The value of a trade-in does not have to be deducted from the pre-discount amount of a new funding request. Applicants are not required to notify USAC of the disposal or trade-in of equipment. However, an applicant disposing of or trading in equipment should make an appropriate entry in its asset register or inventory for E-Rate funded equipment.
